Tract A Legal Description:

That part of Lot 1, H.R. WHITE FIRST SUBDIVISION OF GULL LAKE SHORES and that part of Government Lot 5, Section 16, Township 134 North, Range 29 West, Cass County, Minnesota, described as follows:

Beginning at the southwest corner of said Lot 1; thence South 09 degrees 10 minutes 56 seconds East, bearings are based on the west line of said Lot 1 bearing South 09 degrees 10 minutes 56 seconds East, along the southeasterly extension of the west line of said Lot 1, a distance of 168.28 feet; thence North 64 degrees 00 minutes 20 seconds East, a distance of 169.07 feet; thence North 23 degrees 40 minutes 11 seconds West, a distance of 161.22 feet; thence North 29 degrees 00 minutes 20 seconds West, a distance of 121.53 feet; thence North 30 degrees 01 minutes 46 seconds West, a distance of 103 feet, more or less, to the shoreline of Gull Lake; thence southwesterly along said shoreline to the west line of said Lot 1; thence South 09 degrees 10 minutes 56 seconds West along said west line, a distance of 227 feet, more or less, to the point of beginning.

AND ALSO the Easterly 18.00 feet of Lot 1, Block 2, SQUAW POINT.

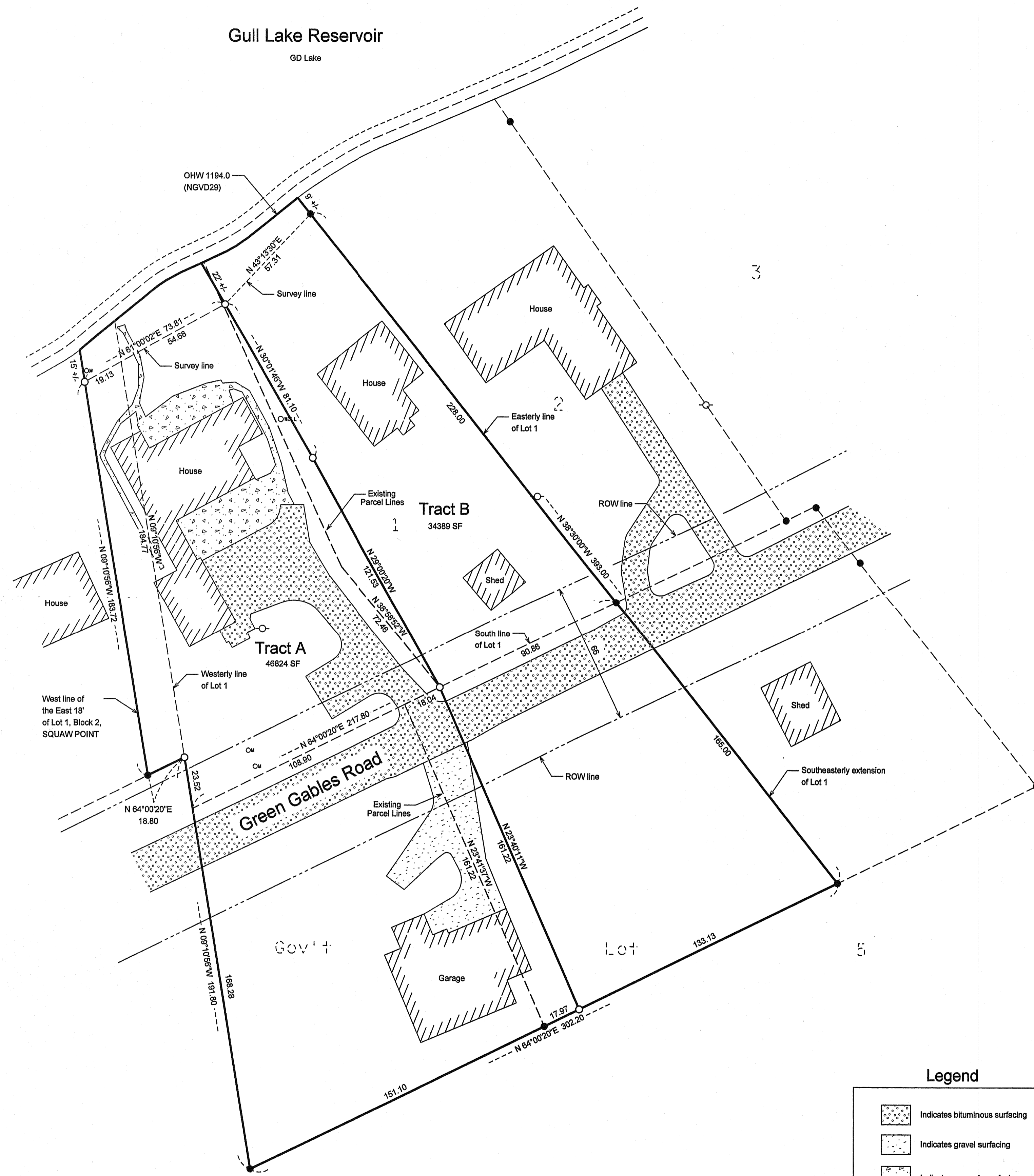
Said parcel contains 46824 square feet, more or less, and is subject to all easements, restrictions or reservations of record, if any.

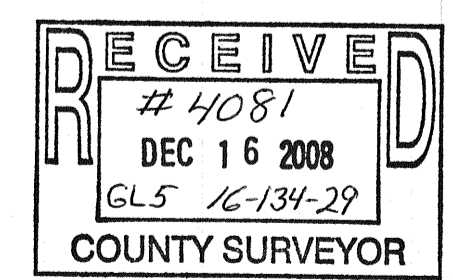
Commencing at the southwest corner of said Lot 1; thence South 09 degrees 10 minutes 56 seconds East, bearings are based on the west line of said Lot 1 bearing South 09 degrees 10 minutes 56 seconds East, along the southeasterly extension of the west line of said Lot 1, a distance of 168.28 feet; thence North 64 degrees 00 minutes 20 seconds East, a distance of 302.20 feet to the southeasterly extension of the east line of said Lot 1 which is the point of beginning of the tract to be described; thence reversing course South 64 degrees 00 minutes 20 seconds West, a distance of 133.13 feet; thence North 23 degrees 40 minutes 11 seconds West, a distance of 161.22 feet; thence North 29 degrees 00 minutes 20 seconds West, a distance of 121.53 feet; thence North 30 degrees 01 minutes 46 seconds West, a distance of 103 feet, more or less, to the shoreline of Gull Lake; thence northeasterly along said shoreline to the east line of said Lot 1; thence South 38 degrees 30 minutes 00 seconds East along the east line of said Lot 1 and its southeasterly extension, a distance of 402 feet, more or less, to the point of beginning.

Said parcel contains 34389 square feet, more or less, and is subject to all easements, restrictions or reservations of record, if any.

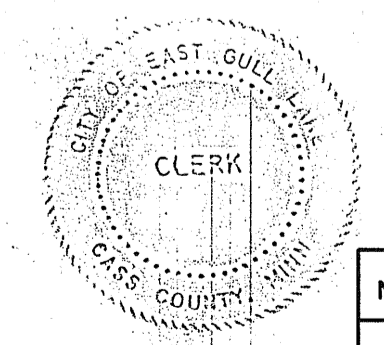
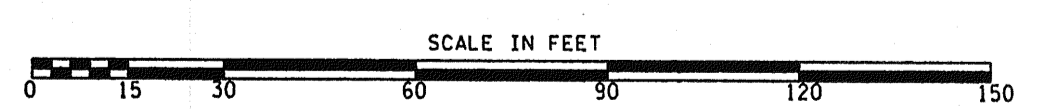

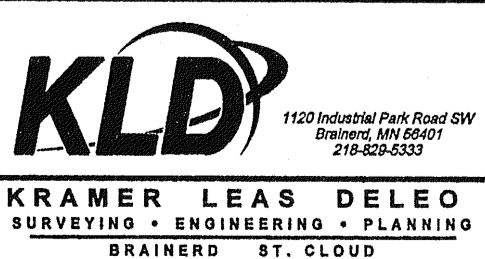
