


# CERTIFICATE OF SURVEY

Lots 61 and 62, CARLYONS SYLVAN PARK, Cass County, Minnesota, according to the recorded plat thereof.

### DESCRIPTION - (PROPOSED)

Lot 62 and those parts of Lots 60 and 61, CARLYONS SYLVAN PARK, according to the recorded plat thereof on file in the office of the County Recorder, Cass County, Minnesota, which lies northerly and westerly of the following described line:

Commencing at the most southeasterly corner of said plat of CARLYONS SYLVAN PARK; thence on an assumed bearing of North 00 degrees 43 minutes 45 seconds West, along the east line of said plat of CARLYONS SYLVAN PARK, a distance of 361.25 feet to the point of beginning of the line to be described; thence North 89 degrees 13 minutes 02 seconds West a distance of 627.97 feet; thence South 11 degrees 06 minutes 04 minutes West a distance of 208.66 feet to the southwesterly line of said Lot 60 and said line there terminating.



Said parcel contains 6.933 acres of land, more or less, and is subject to existing easements of record.
