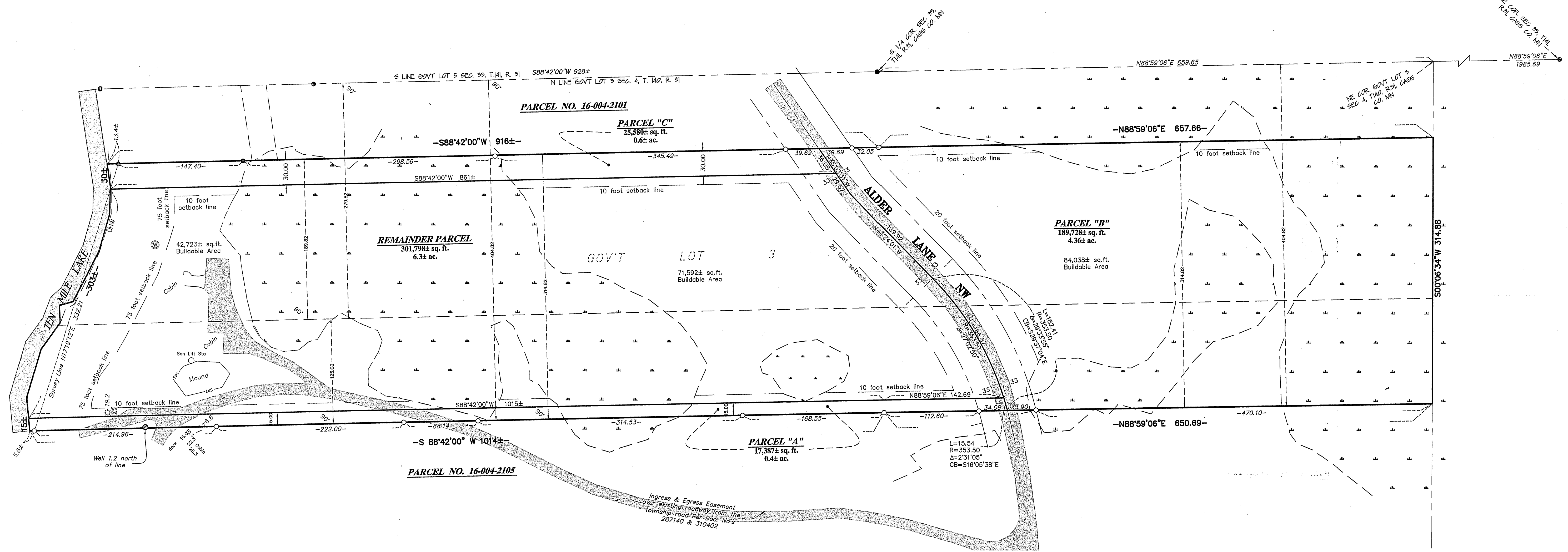
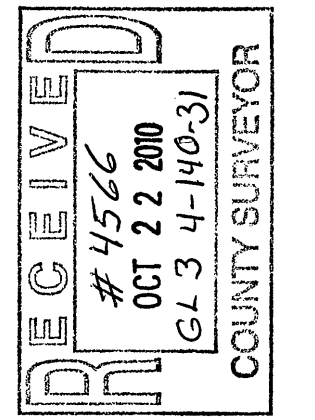


# CERTIFICATE OF SURVEY



**DESCRIPTION - (RECORD)**

**DESCRIPTION - (PARCEL "A")**  
The South 15.00 feet of the North 404.82 feet of Government Lot 3, Section 4, Township 140, Range 31, Cass County, Minnesota, which lies westerly of the centerline of Alder Lane NW.

Said parcel contains 0.4 acres of land, more or less, and is subject to existing easements of record.

**DESCRIPTION - (PARCEL "B")**  
The South 314.82 feet of the North 404.82 feet Government Lot 3, Section 4, Township 140, Range 31, Cass County, Minnesota, which lies easterly of the centerline of Alder Lane NW.

Said parcel contains 4.36 acres of land, more or less, and is subject to existing easements of record.

**DESCRIPTION - (PARCEL "C")**  
The North 30.00 feet of the South 189.82 feet of the North 279.82 feet of Government Lot 3, Section 4, Township 140, Range 31, Cass County, Minnesota, which lies westerly of the centerline of Alder Lane NW.

Said parcel contains 0.6 acres of land, more or less, and is subject to existing easements of record.

**DESCRIPTION - (REMAINDER PARCEL)**  
The South 314.82 feet of the North 404.82 feet Government Lot 3, Section 4, Township 140, Range 31, Cass County, Minnesota, which lies westerly of the centerline of Alder Lane NW, less the South 15.00 feet and the North 30.00 thereof.

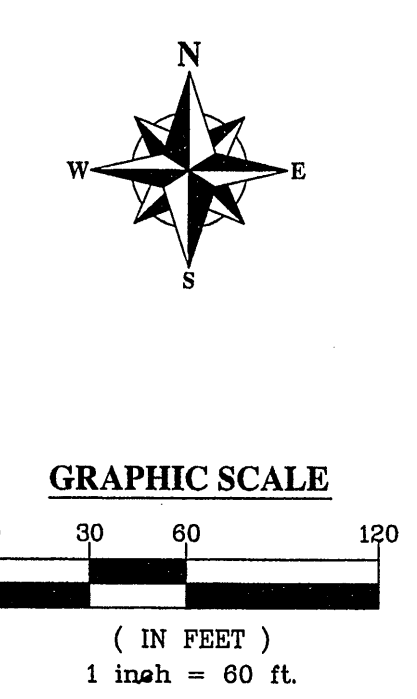
Said parcel contains 6.3 acres of land, more or less, and is subject to existing easements of record.

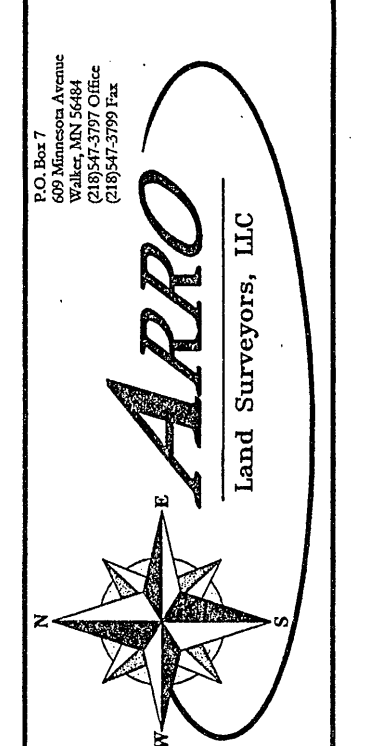

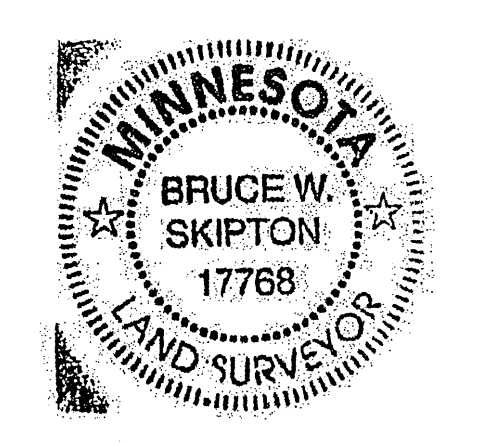
