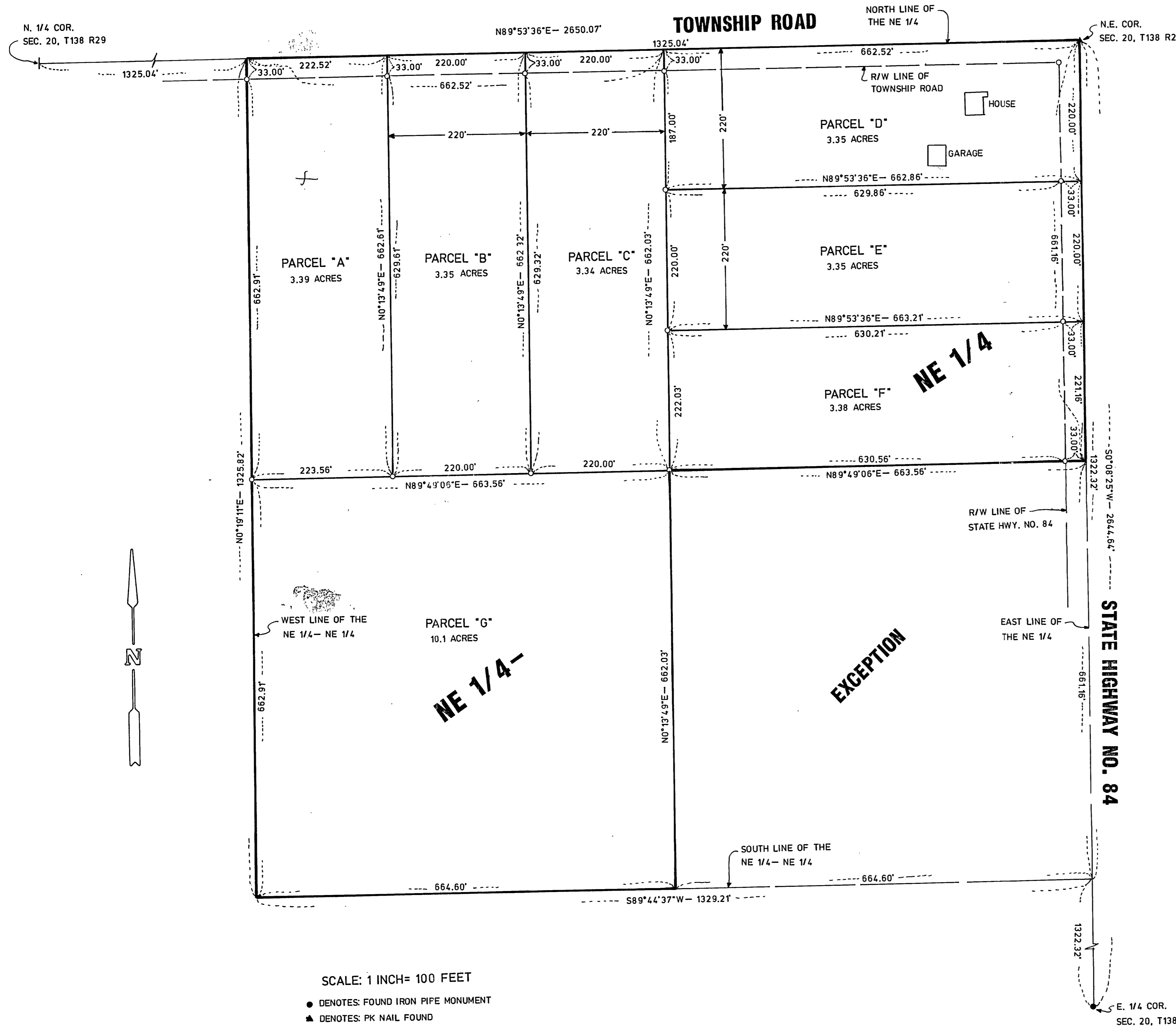

PARCEL A
The Northwest Quarter of the Northeast Quarter of Section 20, Township 138, Range 29, Cass County, Minnesota except the east 440 feet thereof. Subject to right of way for township road on the north.

PARCEL B
The west 220 feet of the east 440 feet of the Northwest Quarter of the Northeast Quarter of Section 20, Township 138, Range 29, Cass County, Minnesota. Subject to right of way for township road on the north.

PARCEL C
The east 220 feet of the Northwest Quarter of the Northeast Quarter of Section 20, Township 138, Range 29, Cass County, Minnesota. Subject to right of way for township road on the north.

PARCEL D
The north 220 feet of the Northeast Quarter of the Northeast Quarter of Section 20, Township 138, Range 29, Cass County, Minnesota. Subject to right of way for township road on the north and subject to right of way for State Highway No. 84 on the east.

PARCEL E
The south 220 feet of the north 440 feet of the Northeast Quarter of the Northeast Quarter of Section 20, Township 138, Range 29, Cass County, Minnesota. Subject to right of way for State Highway No. 84 on the east.

PARCEL F
The Northeast Quarter of the Northeast Quarter of Section 20, Township 138, Range 29, Cass County, Minnesota, except the north 440 feet thereof. Subject to right of way for State Highway No. 84 on the east.

PARCEL G
The Southwest Quarter of the Northeast Quarter of Section 20, Township 138, Range 29, Cass County, Minnesota.
