


# CERTIFICATE OF SURVEY

PART OF GOVERNMENT LOT 1,  
SECTION 18, TOWNSHIP 143 NORTH, RANGE 30 WEST,  
CASS COUNTY, MINNESOTA



## PROPOSED DESCRIPTIONS:

### TRACT A

That part of Government Lot 1, Section 18, Township 143 North, Range 30 West, Cass County, Minnesota, described as follows: Commencing at the Northwest corner of said Government Lot 1 and assuming the north line thereof bears North 88 degrees 45 minutes 00 seconds East; thence South 0 degrees 22 minutes 09 seconds East along the west line thereof 804.69 feet; thence South 77 degrees 05 minutes 56 seconds East 275.40 feet; thence North 36 degrees 00 minutes 10 seconds West 146.65 feet; thence North 69 degrees 39 minutes 09 seconds East 53.66 feet; thence North 74 degrees 59 minutes 35 seconds East 334.10 feet; thence South 80 degrees 54 minutes 27 seconds East 496.98 feet to the point of beginning of the tract to be herein described; thence North 80 degrees 54 minutes 27 seconds West 496.98 feet; thence North 74 degrees 59 minutes 35 seconds East 38.47 feet; thence North 77 degrees 46 minutes 45 seconds East 71.55 feet; thence northeasterly 69.26 feet along a tangential curve concave to the northwest, having a radius of 71.55 feet and a central angle of 55 degrees 27 minutes 45 seconds; thence South 80 degrees 54 minutes 27 seconds East, not tangent to said curve 402.13 feet; thence South 69 degrees 49 minutes 58 seconds East 76 feet, more or less, to the shoreline of Leech Lake; thence southerly along said shoreline to the intersection with a line which bears South 69 degrees 49 minutes 58 seconds East from the point of beginning; thence North 69 degrees 49 minutes 58 seconds West 124 feet, more or less, to the point of beginning.

Subject to and together with easements, restrictions and reservations of record.



