A plat of all of Lot 1, 2, 3, & 4, in Section 19, 1st Township 134 North, in Range 29 West of the 5th P.M., in Cass County, Minnesota. Said plat consisting of Lots Numbered 1 to 163 inclusive, together with all Streets and Alleys as shown herein, and showing iron Monuments and Ties thereto.

Harrison, being the owners and proprietors of the following described land lying and being in the County of Cass, State of Minnesota, to-wit: All of Lots 1, 2, 3, & 4, in Section 19, in Township 134 North, in Range 29 West of the Fifth Principal Meridian, and being desirous of platting the same into Lots, Streets, Avenues and Alleys, have caused the same to be surveyed, and this plat made thereof in accordance with the statutes in such case made and provided, which said plat shall be known as **PINE-BEACH**, and this plat is a true map and plat of said lands, and the owners and proprietors hereby dedicate to the public for street purposes all the streets, avenues and alleys as platted.
