

CROW WING COUNTY, MINNESOTA



**PROPOSED LEGAL DESCRIPTION:**

That part of the North 150.00 feet of the South 800.00 feet of Government Lot 1, Section 31, Township 139 North, Range 29 West, Cass County, Minnesota, lying Easterly of the following described line: Commencing at the Southwest corner of said North 150.00 feet of the South 800.00 feet; thence South 89 degrees 37 minutes 20 seconds East assumed bearing along the South line of said North 150.00 feet a distance of 523.08 feet to the point of beginning of the line to be herein described; thence North 5 degrees 41 minutes 55 seconds West 150.85 feet, more or less, to the North line of said North 150.00 feet and said line there terminating.
