



Subject to a road easement over the west 33 feet and the south 33 feet thereof.

PARCEL B
The south 330 feet of the west 285.81 feet of the east 604.62 feet of the Southwest Quarter of the Southwest Quarter of Section 13, Township 133, Range 30, Cass County, Minnesota.
Subject to a road easement over the west 33 feet thereof, the east 33 feet thereof and the south 33 feet thereof.

PARCEL C
The south 300 feet of the Southwest Quarter of the Southwest Quarter of Section 13, Township 133, Range 30, Cass County, Minnesota, except the west 433 feet thereof and except the east 604.62 feet thereof.
Subject to a road easement over the east 33 feet thereof and the south 33 feet of the east 95.38 feet thereof.

PARCEL D
The South Half of the Southwest Quarter of the Southwest Quarter of Section 13, Township 133, Range 30, Cass County, Minnesota except the south 300 feet thereof and except the east 604.62 feet thereof, and except the south 400 feet of the west 433 feet thereof and except the west 453 feet lying north of the south 400 feet thereof.


PARCEL H
