



### House Tract

That part of Government Lot 2, Section 16, Township 143 North, Range 31 West, Cass County, Minnesota described as follows: Commencing at the Northwest corner of said Government Lot 2; thence South 0 degrees 01 minutes 28 seconds West, assumed bearing along the west line thereof 648.27 feet to the south line of the north half of said Government Lot 2; thence South 89 degrees 50 minutes 23 seconds East along said south line 746.13 feet to the point of beginning of the tract to be herein described; thence North 0 degrees 01 minutes 28 seconds East 327.56 feet; thence South 89 degrees 50 minutes 23 seconds East 644.66 feet, more or less, to the centerline of County Road No. 142; thence South 6 degrees 58 minutes 34 seconds East along said centerline 330.11 feet, more or less, to said south line; thence North 89 degrees 50 minutes 23 seconds West along said south line 684.89 feet, more or less to the point of beginning.
