


Description:

Tract "A" Commencing on the shore of Girl Lake at a point which is the northwesterly corner of Lot 7 Heinlen's Subdivision, Cass County, Minnesota; thence N.74° 06'E. along the northerly boundary of said Lot 7 a distance of 100.0 ft. to the northeasterly corner of said Lot 7; thence continuing on same bearing of N.74° 06'E. a distance of 100.0 feet; thence N.3° 36'E. a distance of 87.0 feet to the point of beginning; thence continuing on same bearing N.3° 36'E. a distance of 87.0 feet; thence N.89° 08'W. a distance of 148.0 feet to the shore of Girl Lake; thence S.30° 08'W. along the shore of Girl Lake a distance of 122.37 feet; thence N.85° 18'E. a distance of 204.63 feet to the point of beginning. Tract containing 0.4 acres more or less.

Tract "B" The point of beginning being a point on the shore of Girl Lake, which is the northwesterly corner of Lot 7, Heinlen's Subdivision, Cass County, Minnesota. thence N.74° 06'E. along the northerly boundary of said Lot 7 a distance of 100.0 feet to the northeasterly corner of said Lot 7; thence continuing on the same bearing of N.74° 06'E. a distance of 100.0 feet; thence N.3° 36'E. a distance of 87.0 feet; thence S.85° 18'W. a distance of 204.63 feet to the shore of Girl Lake; thence southerly along the shore of Girl Lake to the point of beginning. Tract containing 0.5 acres more or less.

Tract "C" Commencing at the southeasterly corner of Lot 8, Heinlen's Subdivision, Cass County, Minnesota; thence N.2° 31'W. along the easterly boundary of said Lot 8 a distance of 310.0 feet to the point of beginning; thence N.74° 07'E. a distance of 97.0 feet; thence N.1° 48'W. a distance of 133.4 feet; thence S.87° 29'W. a distance of 313.4 feet; thence S.46° 10'E. a distance of 227.46 feet; thence S.79° 12'W. a distance of 61.0 feet; to the point of beginning. Tract containing 0.85 acres more or less. Also subject to easement of existing roadway.
