EASEMENT LEGAL DESCRIPTION

A 120.00 foot easement for utility purposes over, under and across Government Lot 3, Section 20, Township 139 North, Range 26 West of the Fifth Principal Meridian, Cass County, Minnesota, with a centerline described as follows:

Commencing at the Northwest corner of said Section 20; thence South 0 degrees 17 minutes 20 seconds East along the west line of the Northwest Quarter, a distance of 2630.66 feet to the West Quarter corner of said Section 20; thence North 89 degrees 12 minutes 59 seconds East along the south line of the Northwest Quarter a distance of 1306.44 feet to the Southwest corner of said Government Lot 3; thence North 0 degrees 09 minutes 04 seconds West, a distance of 564.56 feet to the point of beginning of the centerline to be described; thence South 73 degrees 13 minutes 14 seconds East, a distance of 78.04 feet; thence South 73 degrees 09 minutes 49 seconds East, a distance of 731.17 feet; thence North 80 degrees 54 minutes 37 seconds East, a distance of 539.95 feet to the east line of said Government Lot 3 and said easement centerline there terminates.

The sidelines of said easement are to be prolonged or shortened to terminate on the west line, and on the east line of said Government Lot 3.
