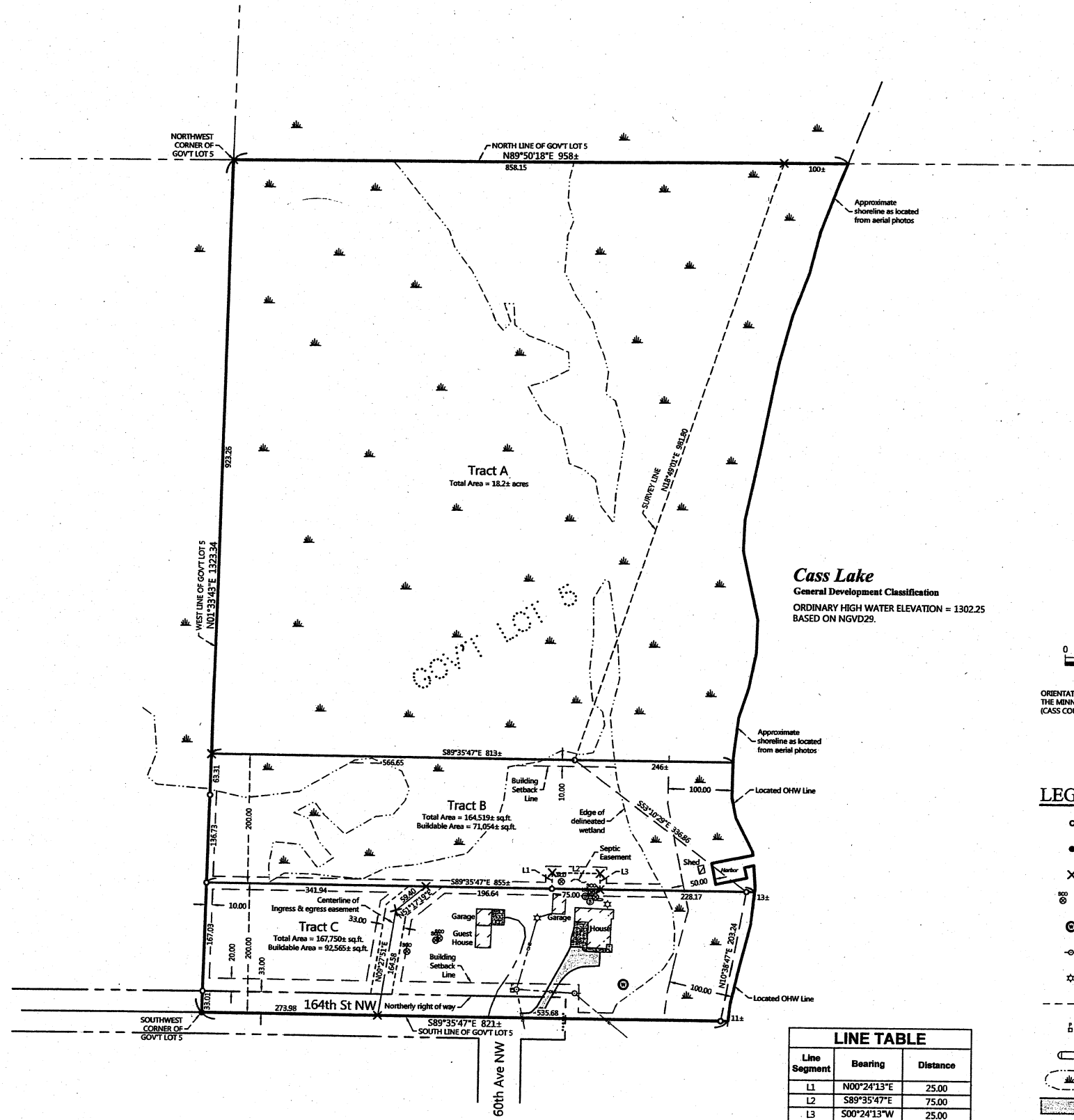


CERTIFICATE OF SURVEY

PART OF GOVERNMENT LOT 5,
SECTION 3, TOWNSHIP 145 NORTH, RANGE 31 WEST,
CASS COUNTY, MINNESOTA



PROPOSED DESCRIPTIONS:

TRACT A
That part of Government Lot 5, Section 3, Township 145 North, Range 31 West, Cass County, Minnesota, which lies north of the South 400.00 feet thereof.

Subject tract is non-conforming on it's own and must be attached to an adjacent parcel.

TRACT B
The North 200.00 feet of the South 400.00 feet of Government Lot 5, Section 3, Township 145 North, Range 31 West, Cass County, Minnesota.

Together with (see 33.00 foot wide ingress and egress easement).
Subject to (see septic easement).

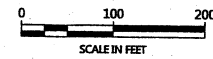
TRACT C
The South 200.00 feet of Government Lot 5, Section 3, Township 145 North, Range 31 West, Cass County, Minnesota.

Subject to and Together with (see 33.00 foot wide ingress and egress easement).
Together with (see septic easement).

INGRESS AND EGRESS EASEMENT
An easement 33.00 feet in width for ingress, egress and utilities over, under and across that part of said Government Lot 5, the centerline of which is described as follows: Commencing at the southwest corner of said Government Lot 5; thence South 89 degrees 35 minutes 47 seconds East, assigned bearing along the south line thereof, a distance of 273.98 feet to the Point of Beginning of the centerline to be herein described; thence North 09 degrees 27 minutes 51 seconds East 164.58 feet; thence North 51 degrees 17 minutes 19 seconds East 59.40 feet, to the North line of the South 200.00 feet of said Government Lot 5 and said centerline there terminating. The sidelines of said 33.00 foot wide easement shall be prolonged or shortened to terminate on said south line and said North line.

SEPTIC EASEMENT
An easement for septic lines, drainfield and their maintenance over, under and across that part of said Government Lot 5, described as follows: Commencing at the northwest corner of the South 200.00 feet of said Government Lot 5; thence South 89 degrees 35 minutes 47 seconds East along the North line of said South 200.00 feet, for a distance of 538.58 feet to the Point of Beginning of the easement tract to be herein described; thence North 00 degrees 24 minutes 13 seconds East 25.00 feet, to said North line; thence North 89 degrees 35 minutes 47 seconds West, along said North line, 75.00 feet to the Point of Beginning. Said septic easement shall be in effect for the life of the existing drainfield.

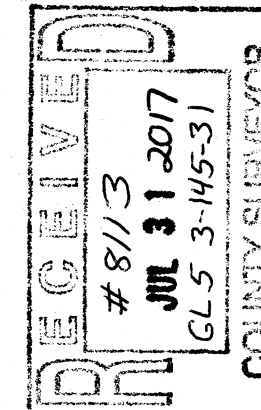
Cass Lake
