## EAST TRACT

That part of the Southeast Quarter of the Southeast Quarter, Section 10, Township 140 North, Range 29 West, Cass County, Minnesota, described as follows: BEGINNING at the northeast corner of said Southeast Quarter of the Southeast Quarter; thence North 87 degrees 50 minutes 59 seconds West, assigned bearing, along the north line thereof, 131.31 feet; thence South 00 degrees 44 minutes 35 seconds East 470 feet, more or less, to the shoreline of Barrow Lake; thence northeasterly along said shoreline to the intersection with the east line of said Southeast Quarter of the Southeast Quarter; thence North 01 degrees 13 minutes 47 seconds East, along said east line, 423 feet, more or less, to the point of beginning. SUBJECT to easements, restrictions, and reservations of record.

The East Tract is a nonconforming tract on its own and will be attached to Parcel No. 51-011-3307.

## WEST TRACT

That part of the Southeast Quarter of the Southeast Quarter, Section 10, Township 140 North, Range 29 West, Cass County, Minnesota, described as follows: COMMENCING at the northeast corner of said Southeast Quarter of the Southeast Quarter; thence North 87 degrees 50 minutes 59 seconds West, assigned bearing, along the north line thereof, 131.31 feet to the point of beginning of the tract to be herein described; thence continue North 87 degrees 50 minutes 59 seconds West, along said north line, 121.00 feet, to a point distant 1052.00 feet from the northwest corner of said Southeast Quarter of the Southeast Quarter; thence South 03 degrees 43 minutes 36 seconds East 559 feet, more or less, to the shoreline of Barrow Lake; thence northeasterly along said shoreline to the intersection a line bearing South 00 degrees 44 minutes 35 seconds East from the point of beginning; thence North 00 degrees 44 minutes 35 seconds West, 470 feet, more or less, to the point of beginning.
