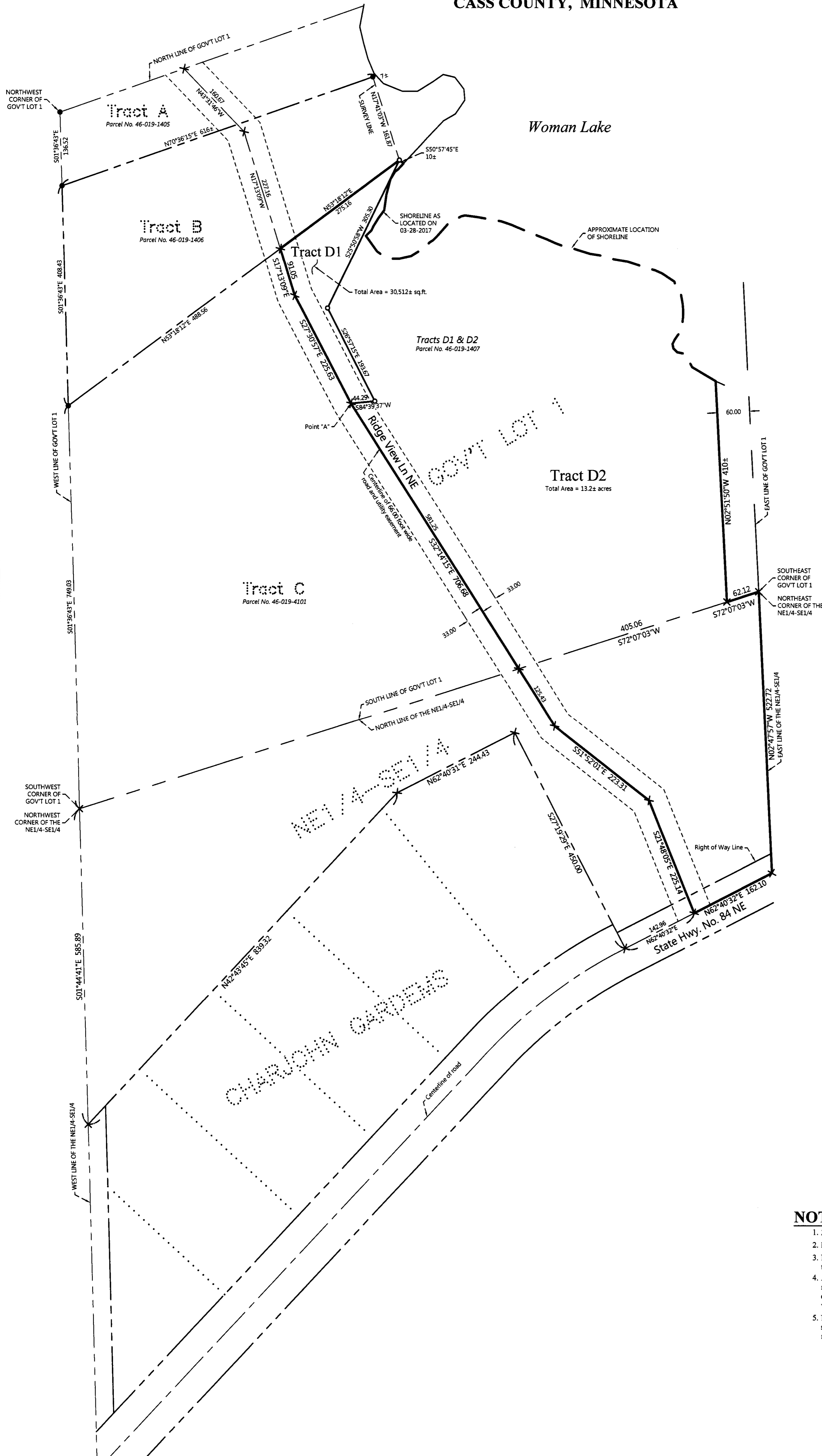


CERTIFICATE OF SURVEY

**PART OF GOVERNMENT LOT 1 AND PART OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER,
SECTION 19, TOWNSHIP 140 NORTH, RANGE 28 WEST,
CASS COUNTY, MINNESOTA**



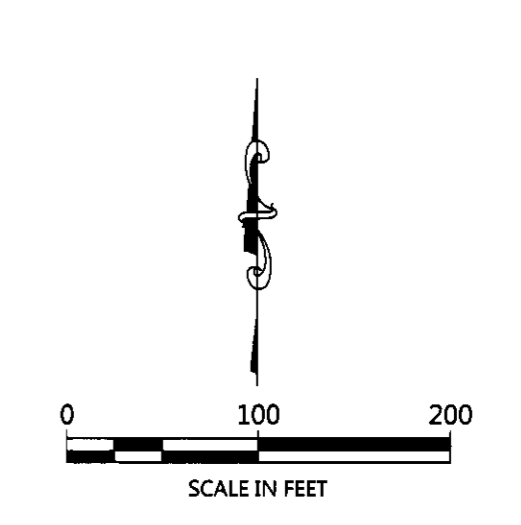
PROPOSED DESCRIPTIONS:

TRACT D1
That part of Government Lot 1, Section 19, Township 140 North, Range 28 West, Cass County, Minnesota, described as follows: COMMENCING at the northwest corner of said Government Lot 1; thence South 01 degrees 36 minutes 43 seconds East, assigned bearing, along the west line thereof, 544.95 feet; thence North 53 degrees 18 minutes 12 seconds East 488.56 feet; thence South 17 degrees 13 minutes 09 seconds East 91.05 feet; thence South 27 degrees 30 minutes 57 seconds East 225.63 feet to the point of beginning of the tract to be herein described; thence North 27 degrees 30 minutes 57 seconds West 225.63 feet; thence North 17 degrees 13 minutes 09 seconds West 225.63 feet; thence North 53 degrees 18 minutes 12 seconds East 275.16 feet; thence South 25 degrees 50 minutes 58 seconds West 305.30 feet; thence South 26 degrees 57 minutes 15 seconds East 193.67 feet; thence South 84 degrees 39 minutes 37 seconds West 44.29 feet to the point of beginning.
SUBJECT TO easements, restrictions, and reservations of record.
SUBJECT TO and TOGETHER with a 66.00 foot wide easement.
NOTE: This tract is nonconforming on its own and must be attached to an adjoining tract.

TRACT D2
That part of Government Lot 1 and that part of the Northeast Quarter of the Southeast Quarter, both in Section 19, Township 140 North, Range 28 West, Cass County, Minnesota, described as follows: COMMENCING at the northwest corner of said Government Lot 1; thence South 01 degrees 36 minutes 43 seconds East, assigned bearing, along the west line thereof, 544.95 feet; thence North 53 degrees 18 minutes 12 seconds East 488.56 feet; thence South 17 degrees 13 minutes 09 seconds East 91.05 feet; thence South 27 degrees 30 minutes 57 seconds East 225.63 feet to a point hereinafter referred to as Point "A"; thence North 27 degrees 30 minutes 57 seconds West 225.63 feet; thence North 17 degrees 13 minutes 09 seconds West 225.63 feet; thence North 53 degrees 18 minutes 12 seconds East 275.16 feet to the point of beginning of the tract to be herein described; thence South 25 degrees 50 minutes 58 seconds West 305.30 feet; thence South 26 degrees 57 minutes 15 seconds East 193.67 feet; thence South 84 degrees 39 minutes 37 seconds West 44.29 feet to said Point "A"; thence South 32 degrees 14 minutes 15 seconds East 708.68 feet; thence South 51 degrees 52 minutes 01 seconds East 223.31 feet; thence South 21 degrees 48 minutes 05 seconds East 225.14 feet to the centerline of State Highway No. 84; thence North 62 degrees 40 minutes 32 seconds East, along said centerline, 162.10 feet to the east line of said Northeast Quarter of the Southeast Quarter; thence North 02 degrees 47 minutes 03 seconds West, along said east line, 522.72 feet to the northeast corner of said Northeast Quarter of the Southeast Quarter; thence South 72 degrees 07 minutes 03 seconds West, along the south line of said Government Lot 1, for a distance of 62.12 feet to the west line of the East 60.00 feet of said Government Lot 1; thence North 02 degrees 51 minutes 50 seconds West, along last said west line, 410 feet, more or less, to the shoreline of Woman Lake; thence northerly, northwesterly, southwesterly, northerly, and northeasterly along said shoreline to the intersection with a line bearing South 50 degrees 57 minutes 45 seconds East from the point of beginning; thence North 50 degrees 57 minutes 45 seconds West 10 feet, more or less, to the point of beginning.

SUBJECT TO easements, restrictions, and reservations of record.
SUBJECT TO and TOGETHER with a 66.00 foot wide easement.

66.00 FOOT WIDE EASEMENT
An easement for road and utility purposes 66.00 feet wide, over, under, and across that part of Government Lot 1 and that part of the Northeast Quarter of the Southeast Quarter, Section 19, Township 140 North, Range 28 West, Cass County, Minnesota, the centerline of which is described as follows: COMMENCING at the southeast corner of said Government Lot 1; thence on an assumed bearing of South 72 degrees 07 minutes 03 seconds West 487.18 feet along the south line of said Government Lot 1 to the point of beginning of the centerline to be described; thence North 32 degrees 14 minutes 15 seconds West 581.25 feet; thence North 27 degrees 30 minutes 57 seconds West 225.63 feet; thence North 17 degrees 13 minutes 09 seconds West 318.21 feet; thence North 43 degrees 31 minutes 46 seconds West 180.67 feet to the north line of said Government Lot 1 and there terminating and from the point of beginning South 32 degrees 14 minutes 15 seconds East 125.43 feet; thence South 51 degrees 52 minutes 01 seconds East 223.31 feet; thence South 21 degrees 48 minutes 05 seconds East 225.14 feet to the centerline of State Highway No. 84 and there terminating.
The sidelines of said 66.00 foot wide easement shall be prolonged or shortened to terminate on said north line of Government Lot 1.
