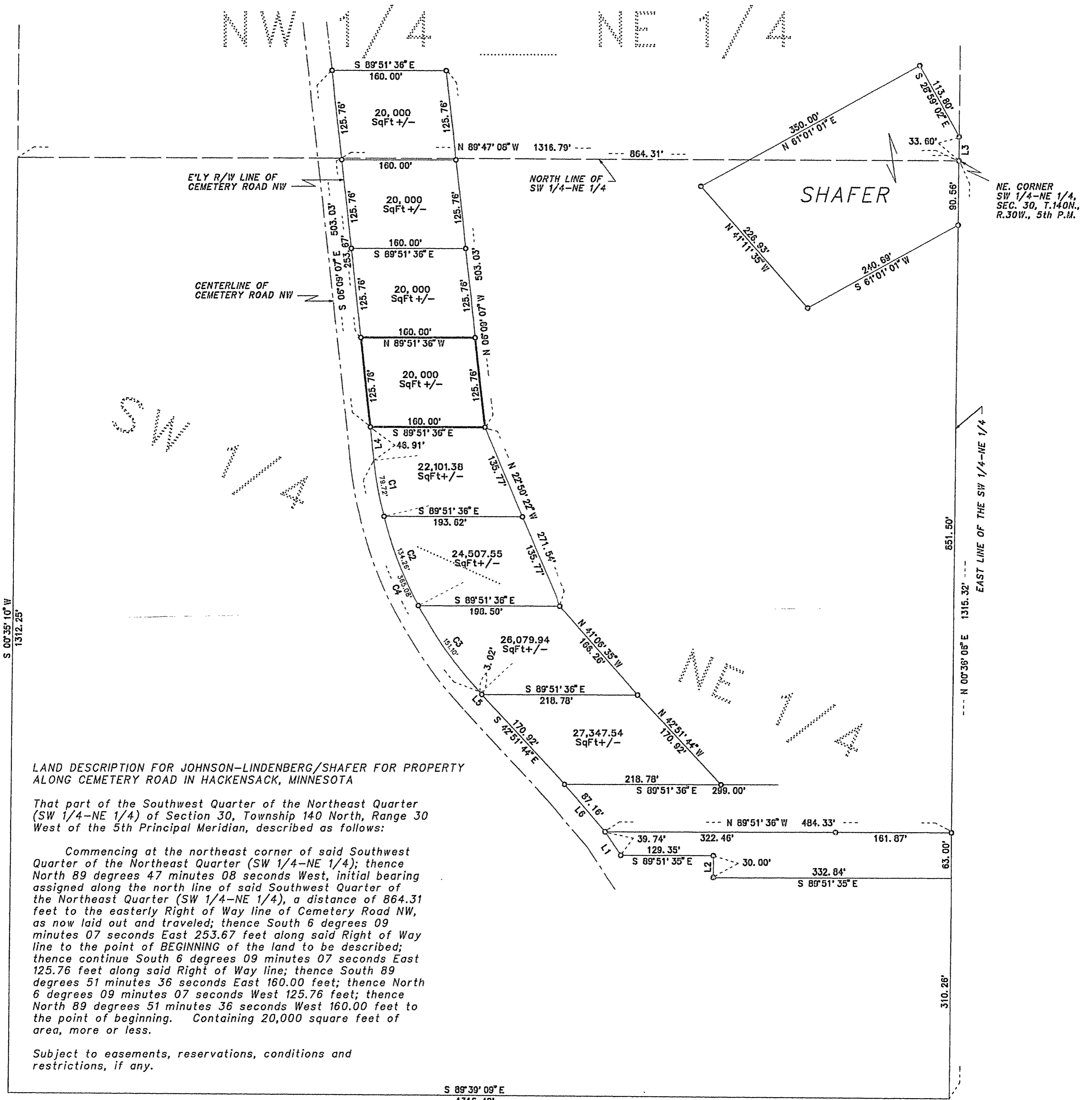

5th PRINCIPAL MERIDIAN IN CASS COUNTY, MINNESOTA



LAND DESCRIPTION FOR JOHNSON-LINDENBERG/SHAFER FOR PROPERTY ALONG CEMETERY ROAD IN HACKENSACK, MINNESOTA

That part of the Southwest Quarter of the Northeast Quarter (SW 1/4-NE 1/4) of Section 30, Township 140 North, Range 30 West of the 5th Principal Meridian, described as follows:

Commencing at the northeast corner of said Southwest Quarter of the Northeast Quarter (SW 1/4-NE 1/4); thence North 89 degrees 47 minutes 08 seconds West, initial bearing assigned along the north line of said Southwest Quarter of the Northeast Quarter (SW 1/4-NE 1/4), a distance of 864.31 feet to the easterly Right of Way line of Cemetery Road NW, as now laid out and traveled; thence South 6 degrees 09 minutes 07 seconds East 253.67 feet along said Right of Way line to the point of BEGINNING of the land to be described; thence continue South 6 degrees 09 minutes 07 seconds East 125.76 feet along said Right of Way line; thence South 89 degrees 51 minutes 36 seconds East 160.00 feet; thence North 6 degrees 09 minutes 07 seconds West 125.76 feet; thence North 89 degrees 51 minutes 36 seconds West 160.00 feet to the point of beginning. Containing 20,000 square feet of area, more or less.

Subject to easements, reservations, conditions and restrictions, if any.
