Subject to easements, restrictions and reservations of record.

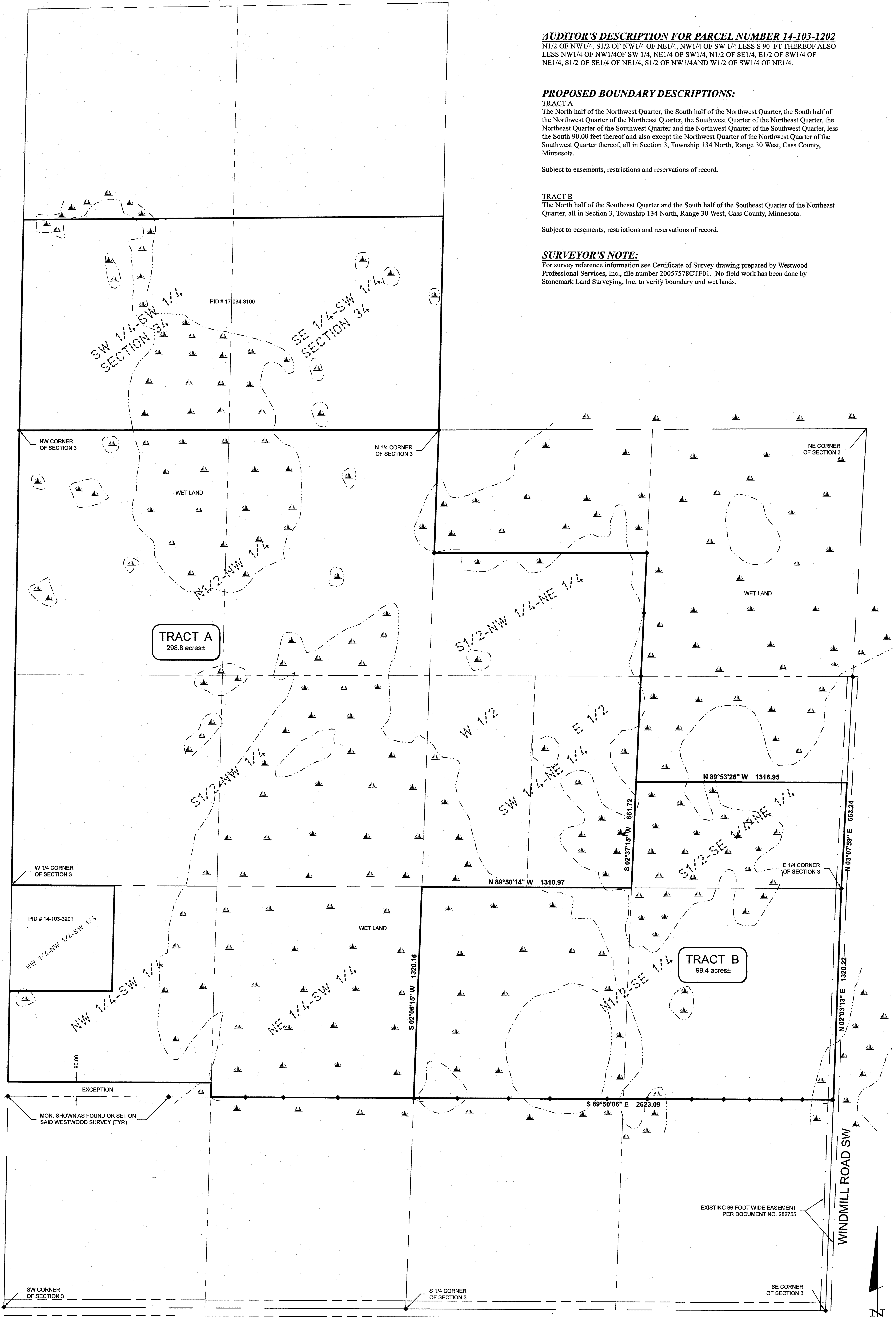
TRACT B

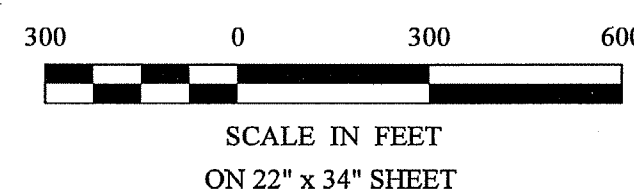
