- 2. The Minnesota Department of Natural Resources has not yet established an Ordinary High Water elevation for Knight Lake. Because of this, the change in wetland/lowland weeds was use to determine the OHW Line shown on this drawing and to be used for Building setback requirements.
- 3. The National Wetland Inventory shown on the Cass County parcel mapping does not show any wetland on the subject property shown on this survey.


