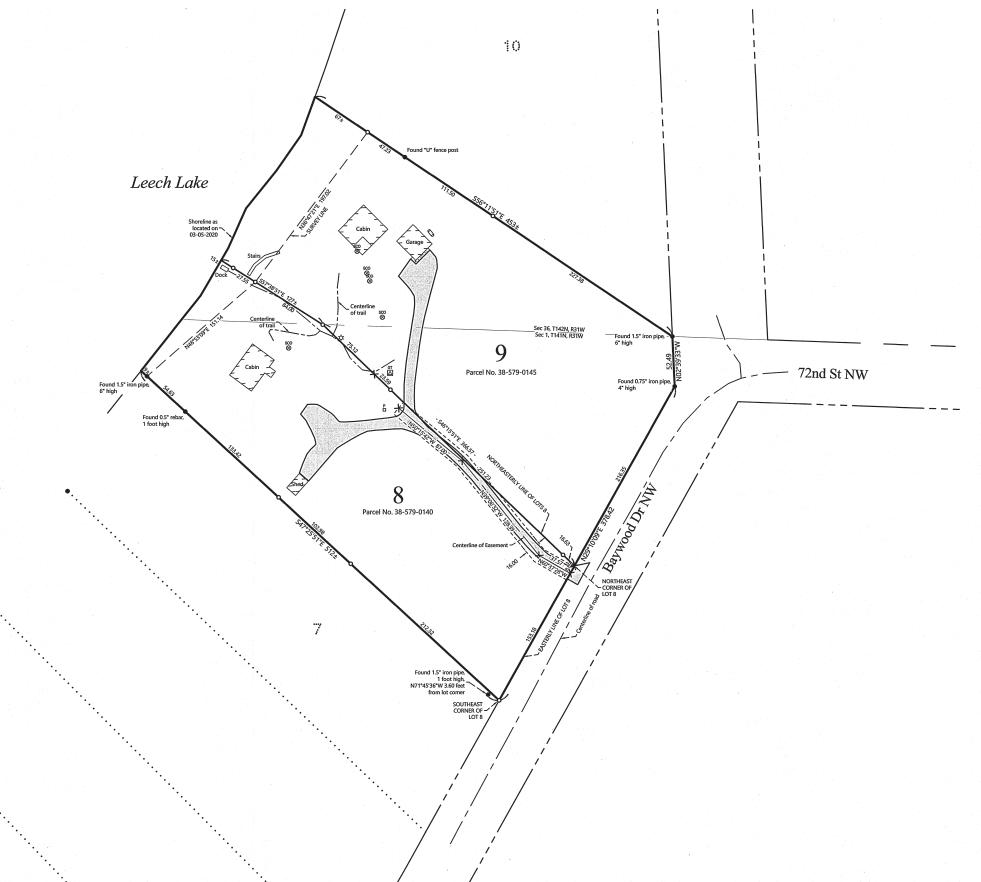

The sidelines of said 16.00 foot wide easement shall be prolonged or shortened to terminate on said easterly line of Lot 8.

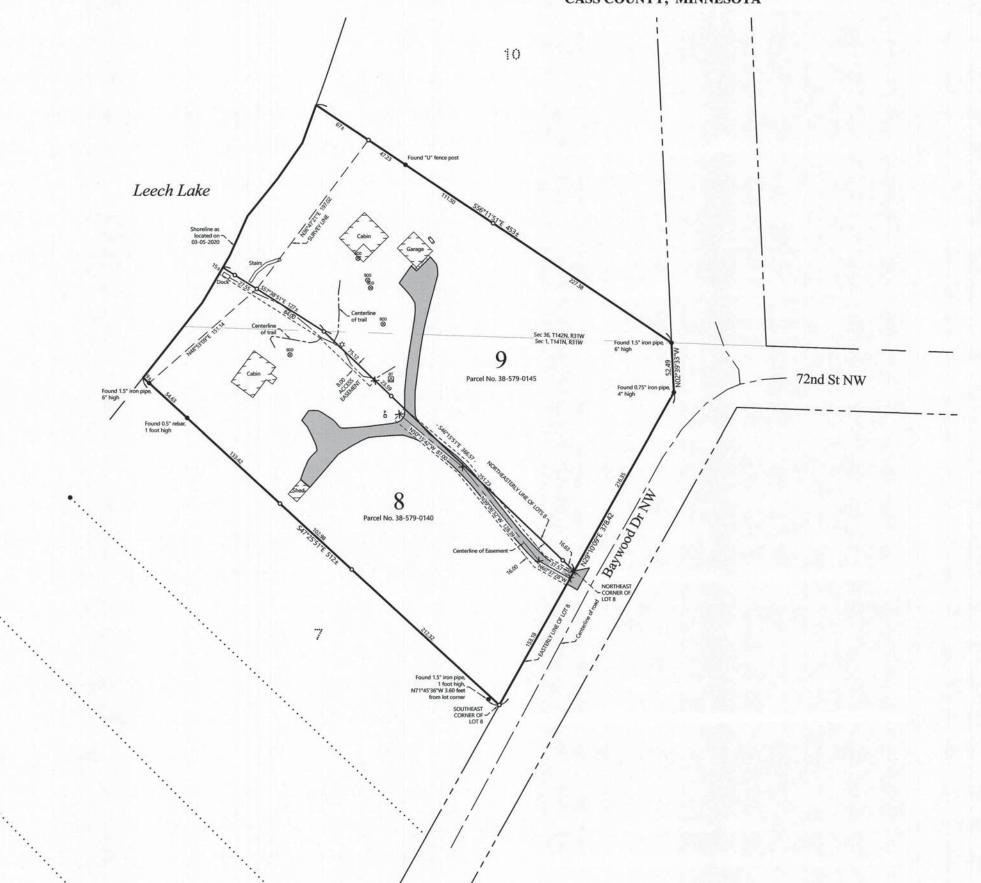

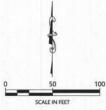

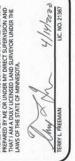
