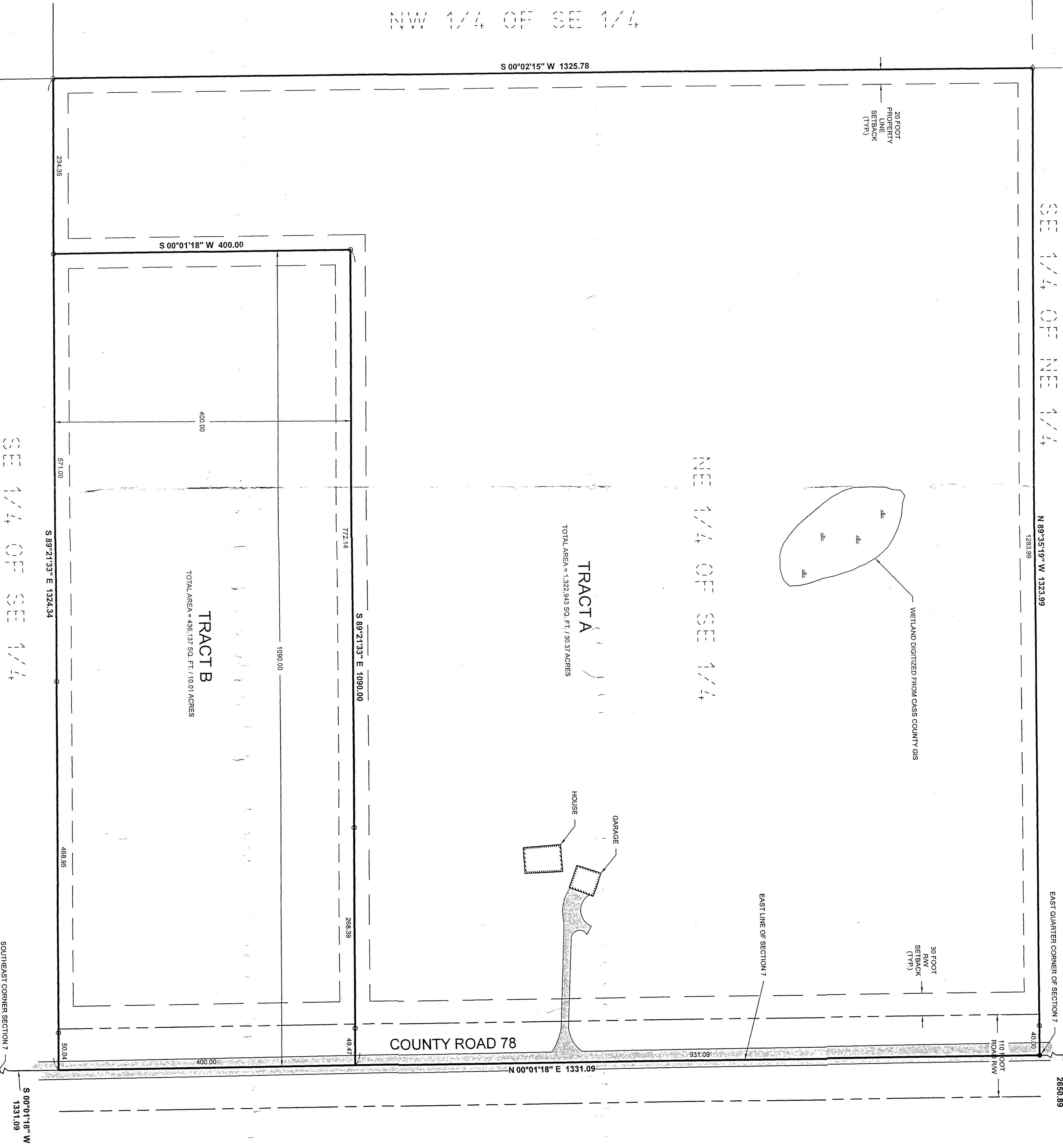


CERTIFICATE OF SURVEY

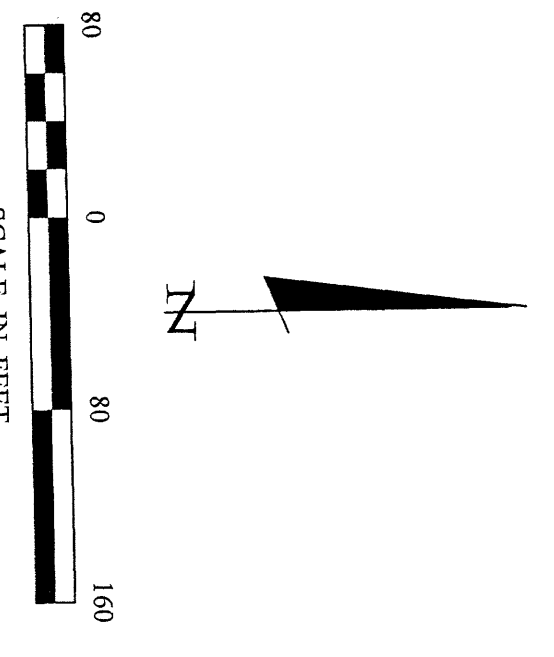
