All that part of Government Lot Two (2), Section Twenty-eight (28), Township One Hundred Forty-one (141), Range Twenty-eight (28), described as follows: Commencing at the Southwest corner of said Government Lot 2 of Section 28; thence North 89 degrees 49 minutes 02 seconds East 543.15 feet, initial bearing assigned, along the South line of said Government Lot 2 of Section 28 to the point of beginning of the land to be described; thence North 9 degrees 28 minutes 27 seconds East 862.89 feet; thence North 75 degrees 17 minutes 42 seconds East 537.24 feet, to the centerline of County Road 125, as laid out and constructed; thence South 19 degrees 35 minutes 23 seconds East 860.28 feet, along said centerline; thence Southeasterly 188.52 feet along a tangential curve, concave to the Northeast having a radius of 1704.36 feet, a central angle of 6 degrees 20 minutes 15 seconds and the chord of said curve bears South 22 degrees 45 minutes 31 seconds East for 188.42 feet, to said South line of Government Lot 2; thence South 89 degrees 49 minutes 02 seconds West 1023.01 feet, not tangent to said curve, to the point of beginning.

LESS All that part of Government Lot 2, Section 28, Township 141, Range 28, described as follows: Commencing at the Southwest corner of said Government Lot 2 of Section 28; thence North 89 degrees 49 minutes 02 seconds East 543.15 feet, initial bearing assigned, along the South line of said Government Lot 2 of Section 28 to the point of beginning of the land to be described; thence North 9 degrees 28 minutes 27 seconds East 260.00 feet; thence North 89 degrees 49 minutes 02 seconds East 878.05 feet to the centerline of County Road 125, as laid out and constructed; thence South 19 degrees 35 minutes 23 seconds East 87.29 feet, along said centerline; thence Southeasterly 188.52 feet along a tangential curve, concave to the Northeast having a radius of 1704.36 feet, a central angle of 6 degrees 20 minutes 15 seconds and the chord of said curve bears South 22 degrees 45 minutes 31 seconds East for 188.42 feet, to said South line of Government Lot 2; thence South 89 degrees 49 minutes 02 seconds West 1023.01 feet, not tangent to said curve, to the point of beginning.
