


CERTIFICATE OF SURVEY

PROPOSED DESCRIPTION:


Tract A

That part of the Government Lot 3, Section 10, Township 139 North, Range 29 West, Cass County, Minnesota, described as follows: COMMENCING at the northeast corner of Lot 3, SNODGRASS' FIRST ADDITION TO EAST SHORE, plat of record, said County; thence South 68 degrees 29 minutes 03 seconds East, assigned bearing, along the extension of the north line of said Lot 3 a distance of 16.00 feet to the Point of Beginning of the tract to be herein described; thence continue South 68 degrees 29 minutes 03 seconds East, along said easterly extension, 111.00 feet; thence South 21 degrees 30 minutes 57 seconds West 150.00 feet to the intersection with the easterly extension of the southerly line of line of said Lot 3; thence North 68 degrees 29 minutes 03 seconds West, along last said easterly extension, 111.00 feet to the easterly line of said Lot 3; thence North 21 degrees 31 minutes 01 seconds East 150.00 feet to the point of beginning. Subject tract is non-conforming on it's own and must be attached to an adjacent parcel. SUBJECT to East Ponto Lake Road NW.

16.00 Foot Roadway Vacation

That part of the 16 Foot Roadway as dedicated in SNODGRASS' FIRST ADDITION TO EAST SHORE, plat of record, Cass County, Minnesota, lying between the easterly extensions of the southerly and northerly lines of Lot 3, said plat. SUBJECT to East Ponto Lake Road NW.
