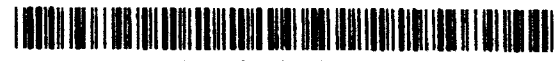

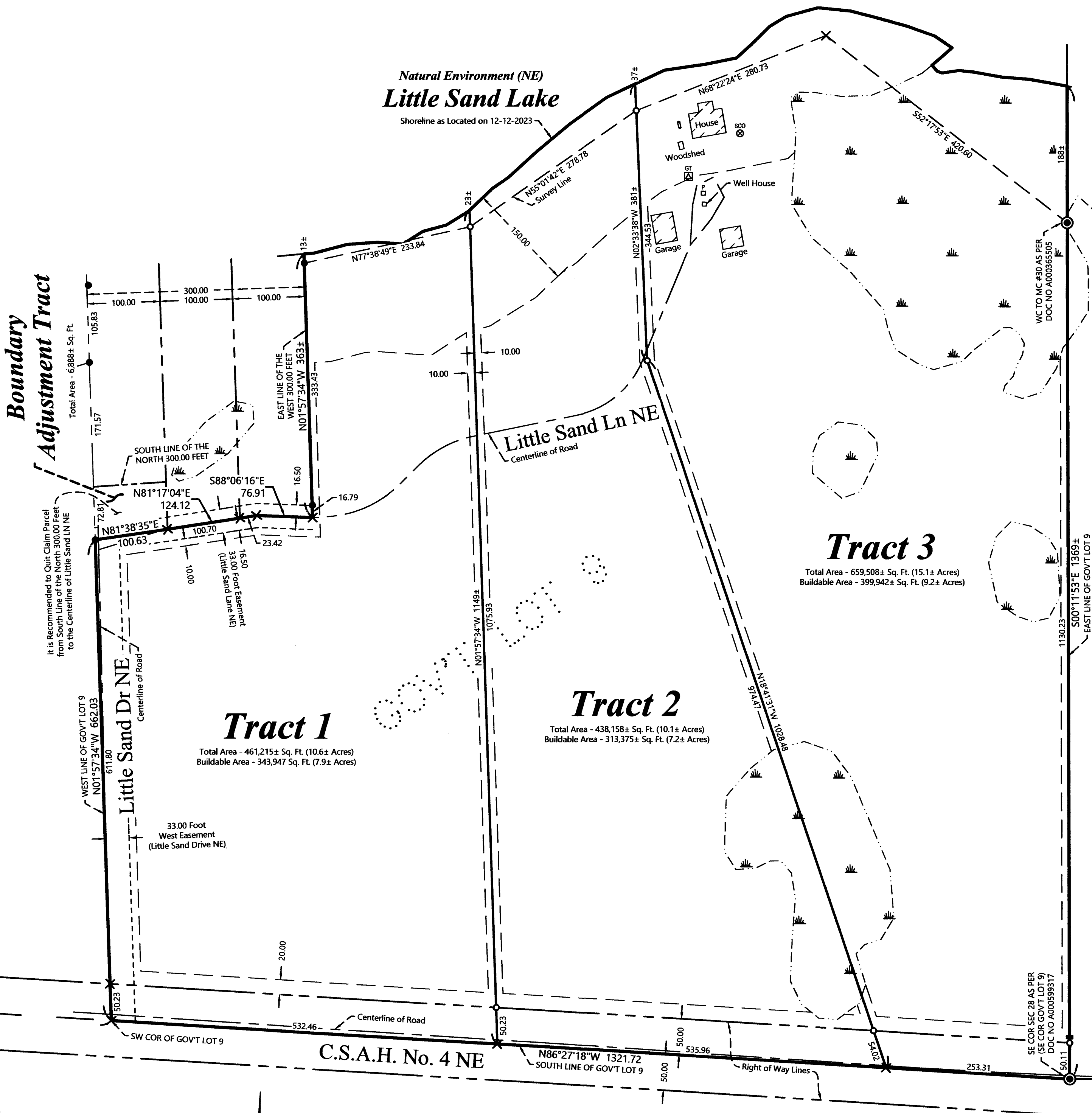
Boundary Adjustment Tract

33.00 Foot Easement (Little Sand Lane NE)
An easement for ingress, egress and utilities 33.00 feet in width over, under and across that part of Government Lot 9, Section 28, Township 142 North, Range 26 West, Cass County, Minnesota, the centerline of which is described as follows: COMMENCING at the southwest corner of said Government Lot 9; thence North 01 degrees 57 minutes 34 seconds West, along the west line of said Government Lot 9, a distance of 662.03 feet to the centerline of Little Sand Ln NE and the centerline of said 33.00 foot wide easement to be herein described; thence North 81 degrees 38 minutes 35 seconds East, along said centerline, 100.63 feet; thence North 81 degrees 17 minutes 04 seconds East, along said centerline, 124.12 feet; thence South 88 degrees 06 minutes 16 seconds East, along said centerline, 76.91 feet to the east line of the West 300.00 feet of said Government Lot 9 and said described centerline there terminating.

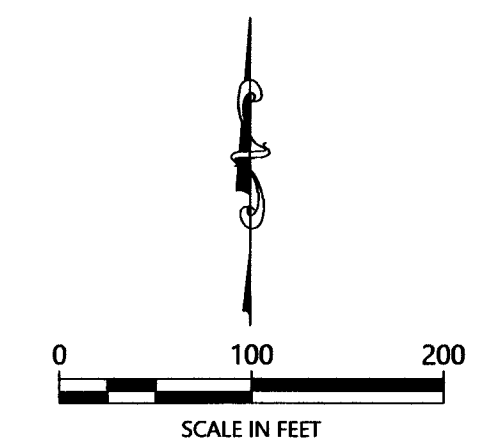
