Subject to and together with an easement for ingress and egress 33.00 feet in width over and across that part of Government Lot 4, Section 23, Township 142 North, Range 28 West, Cass County, Minnesota, the centerline of which is described as follows: Commencing at the Southwest corner of said Government Lot 4; thence South 89 degrees 59 minutes 00 seconds East, assumed bearing along the South line thereof 295.34 feet; thence North 9 degrees 30 minutes 40 seconds East 66.48 feet; thence North 27 degrees 44 minutes 06 seconds West 87.89 feet; thence North 43 degrees 09 minutes 02 seconds West 77.13 feet; thence northerly 72.30 feet along a tangential curve concave to the east, having a radius of 100.00 feet and a central angle of 41 degrees 25 minutes 29 seconds; thence North 1 degree 43 minutes 33 seconds West, tangent to said curve 62.92 feet; thence North 19 degrees 34 minutes 40 seconds West 88.81 feet; thence North 36 degrees 25 minutes 48 seconds West 43.00 feet, and said centerline there terminating. The sidelines of said 33.00 foot wide easement shall be prolonged or shortened to the South line of said Government Lot 4, and at a bearing of North 89 degrees 58 minutes 30 second West, and South 89 degrees 58 minutes 30 seconds East at the point of termination.


- The delineated wetland as shown done by Mitch Brink, Brinks Wetland Services, and the delineation was done only on parcel 07-023-1410.
