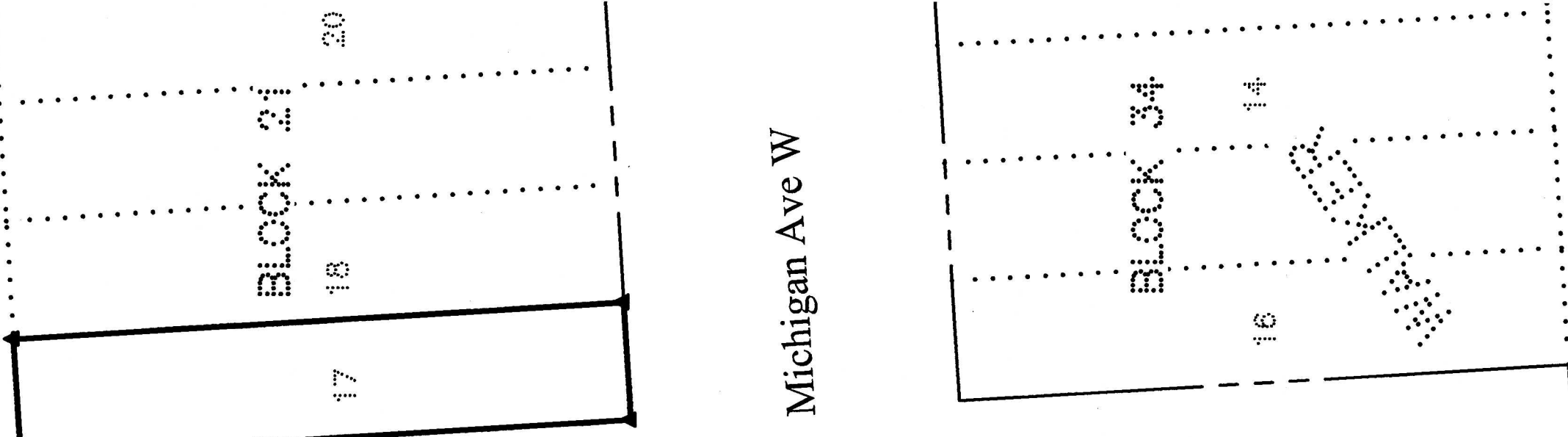


**PARTS OF THE ORIGINAL PLAT OF WALKER, AND

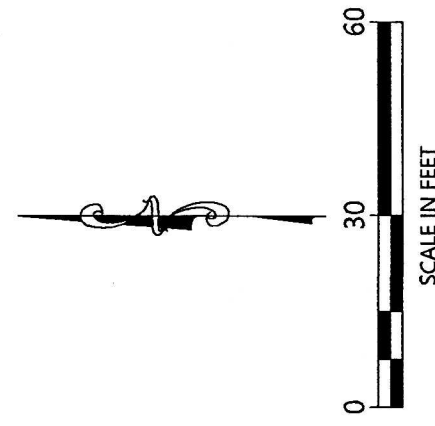
