For the East Quarter Corner of Section 19, Township 143 North, Range 26 West of the 5th Principal Meridian, STATE OF MINNESOTA, County of Cass.

On April 23, 1986, to mark this corner position, we set a 2.5 inch (outside diameter) by 60 inch-long galvanized iron pipe, with a polystyrene base containing an embedded magnetized pellet, and topped with a 3 inch diameter brass tablet, up 18 inches and stamped as shown in the sketch.

STATEMENT OF EVIDENCE: For the East Quarter Corner of Section 19, Township 143
North, Range 26 West of the 5th Principal Meridian.

This corner position-was originally established on August 28, 1872 by Eli W. Griffin, Deputy Surveyor, under contract to the General Land Office, now the Bureau of Land Management (BLM). The record of this survey is on file in the Office of the Secretary of State, St. Paul, Minnesota, and indicates the Mr. Griffin set a wood-post to mark this corner position. This monumented corner position was referenced by: a 14 inch diameter Cedar that bears SOUTH 41 degrees EAST, a distance of 7 link (4.62-feet); and a 6 inch diameter Cedar that bears NORTH 40 degrees WEST, a distance of 8 links (5.28 feet).

Recorded on pages 81 thru 85 of County Survey Record Book B in the Office of the Cass County Recorder is a survey by John Curo, circa 1915. This record indicates that Mr. Curo found an old stake and: a downed Cedar, 14 inches in diameter, that bears SOUTH 41 degrees EAST, a distance of 7 links (4.62 feet); and a downed Cedar, 6 inches in diameter, that bears NORTH 40 degrees WEST, a distance of 8 links (5.28 feet). The record further states that Mr. Curo added: an 8 inch diameter Balsam that bears SOUTH-37 degrees 44 minutes WEST, a distance of 114.10 feet; and a 5 inch diameter Ash that bears NORTH 66 degrees WEST, a distance of 108.10 feet.

No other intervening records were found and our search of the area failed to uneover any evidence of the corner position. I feel that the 1915 Curo survey is the best evidence of this corner position and determined the obliterated position monumented from Mr. Curo's bearings and distances. This obliterated position was monumented and referenced as shown on the front of this document.
