## CERTIFICATE OF LOCATION OF GOVERNMENT CORNER

For the East Quarter Corner of Section 29, Township 143 North, Range 26 West of the 5th Principal Meridian, STATE OF MINNESOTA, County of Cass.

On June 3, 1986, to mark this corner position, we set a 2.5 inch (outside diameter) by 24 inch long galvanized iron pipe containing an embedded magnetized pellet at its base, and topped with a 3 inch diameter brass tablet just below road surface and stamped as shown in the sketch.

STATEMENT OF EVIDENCE: For the East Quarter Corner of Section 29, Township 143

North, Range 26 West of the 5th Principal Meridian.

This-corner-was eriginally set-on-August 27, 1872, by Eli W. Griffin, Deputy Surveyor, under contract-to the General Land Office, now the Bureau of Land Management (BLM) - The record of this survey is on file in the Office of the Secretary of State, St. Paul, Minnesota, and indicates that a wood post was set to mark-this corner position. This monumented position was referenced by: a 8 inch diameter Birch that bears NORTH-32-degrees EAST a distance of 6 links (3.96 feet); and a 8 inch diameter Birch that bears SOUTH 13 degrees WEST a distance of 30 links (19.80 feet).

On record in the Office of the Cass County Recorder in SURVEYOR'S RECORD, Book C, page 151, is a record of a James H. Flynn survey from 1919. This record indicates that that Mr. Flynn set an iron monument at proportionate distance and referenced by: an 6-inch-diameter Ironwood that bears NORTH 37 degrees EAST a distance of 47.30-feet; and an-12-inch diameter Elm that bears SOUTH 63 degrees WEST a distance of 38.50 feet.

No other record of visitation to this corner position was found and no physical evidence of this corner position was found during our search of the area. I feel that Mr. Flynn's 1919 survey information serves as collateral evidence and I reestablished a position for this corner using the fence line to the west for latitudinal control and prorated distances between recovered corners through the center-of-Section 29-to establish longitudinal control. We then monumented and referenced this position as shown on the front of this document.
