1874 P. H. Conger, U.S. Deputy Surveyor, originally established this corner position while subdividing Township 141 North, Range 28 West. The notes indicate a wood post was set to mark the corner position and the following witnesses: a 5 inch Cedar North 50 degrees East a distance of 14 links; and a 4 inch Cedar North 45 degrees West a distance of 12 links.

1938 Civilian Conservation Corps found post in fair condition 18 inches above ground; a 6 inch Cedar North 31 and 1/2 degrees West a distance of 12 links; and an 8 inch North 62 and 1/2 degrees East a distance of 19 links.

1963 George Claydon plats AUDITOR'S PLAT OF LONGVILLE. Plat does not show monument in place. The plat does show, through mathematics, the Sixteenth lines necessary to reconstruct this corner position.

1986 U.S. Forest Service crews set an aerial target in the vicinity of this corner for the search and establishment of the true corner position. The target having coordinate values through the use of GPS on the Chippewa South Boundary Project Cadastral Survey U.S. Project Number 53-6392-8-219. This target allowed for the search and location of this corner.

1987 Roger Mustonen, Licensed Land Surveyor Number 11946, reestablishes this corner as obliterated from AUDITOR'S PLAT OF LONGVILLE. He sets a 2 inch stamped, brass capped iron pipe monument.

1988 a Landecker-Stevenson & Associates crew searched for the corner. The following information was found and noted: a 2 inch iron pipe with a brass cap stamped with Registered Land Surveyor Number 11946 (Roger Mustonen) in Cedar, Spruce and Balsam swamp; no evidence of bearing trees from 1874 or 1938 found. March 1 a Landecker-Stevenson & Associates crew take solar observation and tie monument set by Roger Mustonen in 1987 to U.S. Forest Service coordinate system. This corner mathematically fit the reconstruction as indicated on the AUDITOR'S PLAT OF LONGVILLE. This monument was accepted as monumented by Mustonen. His 1987 bearing trees were remarked as shown and a steel sign post is in place as noted on front of this certificate.
