1865

U.S. General Land Office survey set a wood post for this corner (Closing Corner) and marked the following bearing trees: 20" Norway Pine S31W 39 lks., 11" Norway Pine S21E 54 lks.

1965

U.S. Forrestry Service Surveyor William Okerman found remains of the original survey and a more recent survey marked with a 1½" iron pipe. Both B.T.'s are burnt stumps. Set a 2"x 5' galvanized iron pipe filled with concrete topped with 3" bronze tablet. Marked two new bearings: 15" Jack Pine S50E 64.6' and 5" Elm S32W 39.4'. Both of these were scribed. Steel sign post 7.5' west with USFS signs. Filed affidavit as to the location of government corner.

1987

On March 31, Survey Technician Terry Freeman and Forrester Larry Olson found both iron pipes and the 1965 trees. Marked two new B.T.'s as the Jack Pine is dead and the Elm is dying. The new B.T.'s are: Twin 10" Red Oak S24W 17.0' and 6" Burr Oak N16W 51.25'. This certificate is an update of the 1965 certificate.
