North Quarter Corner, Section 32, Township 134 North, Range 30 West, Cass County, Mn.

N. Butler, U.S. Deputy Surveyor sets a wooden post for this corner during the original survey of the interior subdivision of Township 134 North, Range 30 West and witnesses it with the following bearing trees:

11" BL Pine North 37° East 24 Links 12" BL Pine South 78° East 33 Links

2003 Patrick Trottier, Land Surveyor, License # 41002, employed by Landecker and Associates Inc. of Pequot Lakes, Minnesota, searches diligently for physical and related paper evidence of said post and finds none. A search of the Cass County Survey records revealed that Kevin J. Metz, Land Surveyor, License No. 40343, established a position for this North Quarter corner by single proportion method. He noted that his position lies approximately 10 feet South of an old fence line and 30 feet south of an old road grade. Witness testimony from Phyllis Delonais, long time land owner of abutting property, verified Mr. Metz's belief that the road was built by Potlatch Corp. not on the section line but North thereof.

An expansion of Mr. Trottier's search to adjacent Government Corners reveal the Southeast Corner of said Section 29 is marked with a Cass County Cast Iron Monument as recorded in CERTIFICATE OF LOCATION OF GOVERNMENT CORNER" Document # 302269.

No physical evidence of the Southwest Corner of said Section 29 was found, however, a search of the Cass County Surveyors records reveals in 2002 Mr. Metz establishes the position for this corner and files the following statement:

"After extensive field search for evidence of this corner, and after finding none, other than a few strands of old barbed wire fence, this corner position was established by double proportion using the Northeast Corner of Section 30-134-30, the Northwest Corner of Section 31-134-30, the Southwest Corner of Section 32-134-30. This was done in agreement with David Landecker, of Landecker and Associates, and Bob Kovanen, Cass County Surveyor. This position lies Easterly of a Tamarack swamp, which is in agreement with the original Government running notes, and nearly on-line, North-South, with the found strands of barbed wire fence, which agrees with 1921 notes from John Greene, Land Surveyor, Walker, Mn."

Mr. Trottier sets a ½" plastic capped iron pipe # 17008 at this location from which:
