

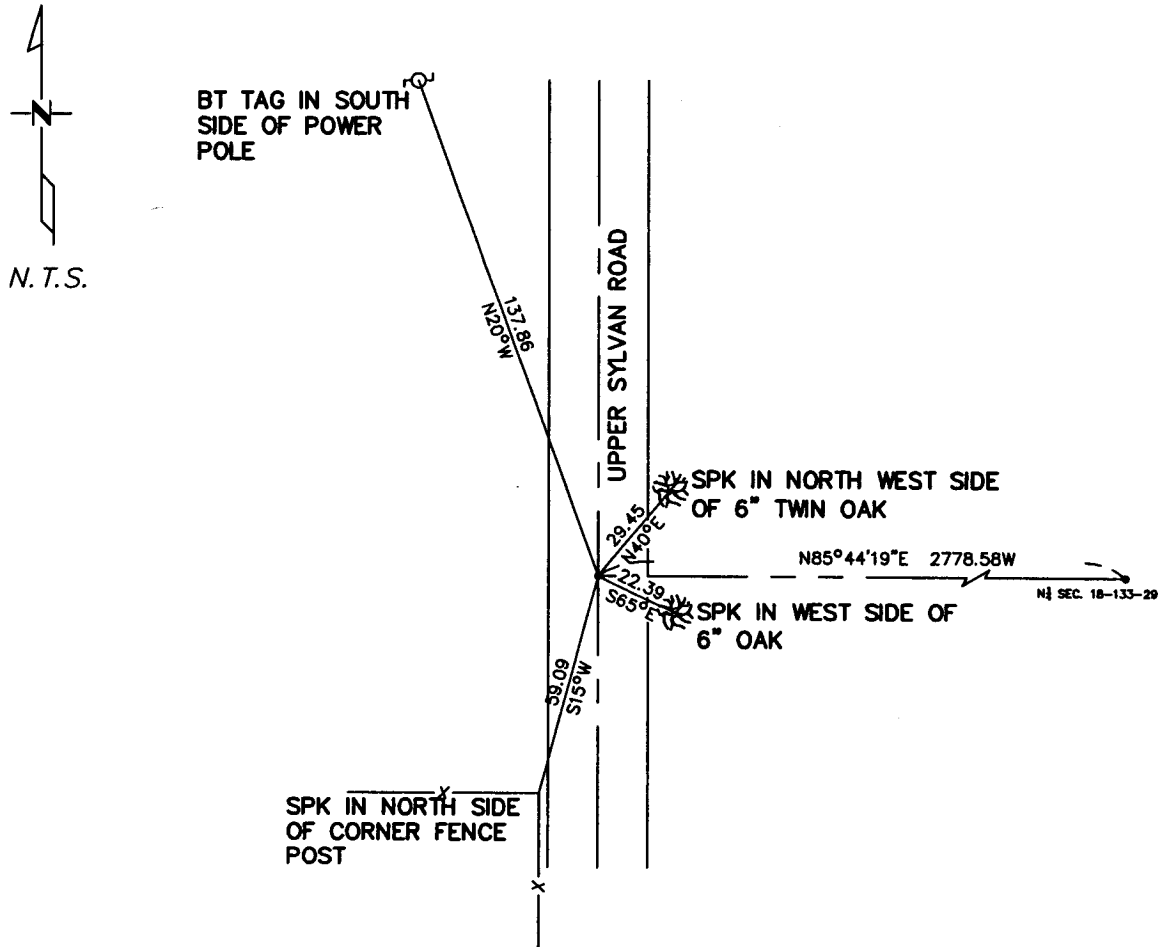

Northeast Corner, Section 13, T. 133N. R. 30W., 5th P.M.

- 1858 – Wood post was set for corner.
- 1912 – John Curo set iron pipe in concrete from old Gov't B.T. County Survey Record Book "A", P. 434–443.
- 1915 – John Curo found previously set iron pipe, Book "B", P. 422–432)
- 1915 – P.R. Boese (microfilm – roll 105, Book 65, p. 10–11)
- 1972 – Dean Anderson plat of SCEARCYVILLE shows monument.
- 1974 – Myron Landecker plat of RISNES ADDITION TO SCEARCYVILLE shows monument.
- 1979 – Bruce R. Buxton plat of THIRD ADDITION TO SCEARCYVILLE shows monument.
- 1999 – Cass County Surveyor's Office (Job #98027) found 3/4" OD iron pipe down 0.2' in centerline of Sylvan Road.
- 2002 – Cass County Surveyor's Office found 1/2" iron pin down 0.3' and 1'± west of centerline.
- 2003 (Mar) – Bruce Grivna (#17253) shows monument found on Certificate of Survey.
- 2003 (Sept) – Bruce Grivna (#17253) shows monument found on Certificate of Survey.
- 2004 (June) – Bruce Grivna (#17253) shows monument found on Certificate of Survey.
