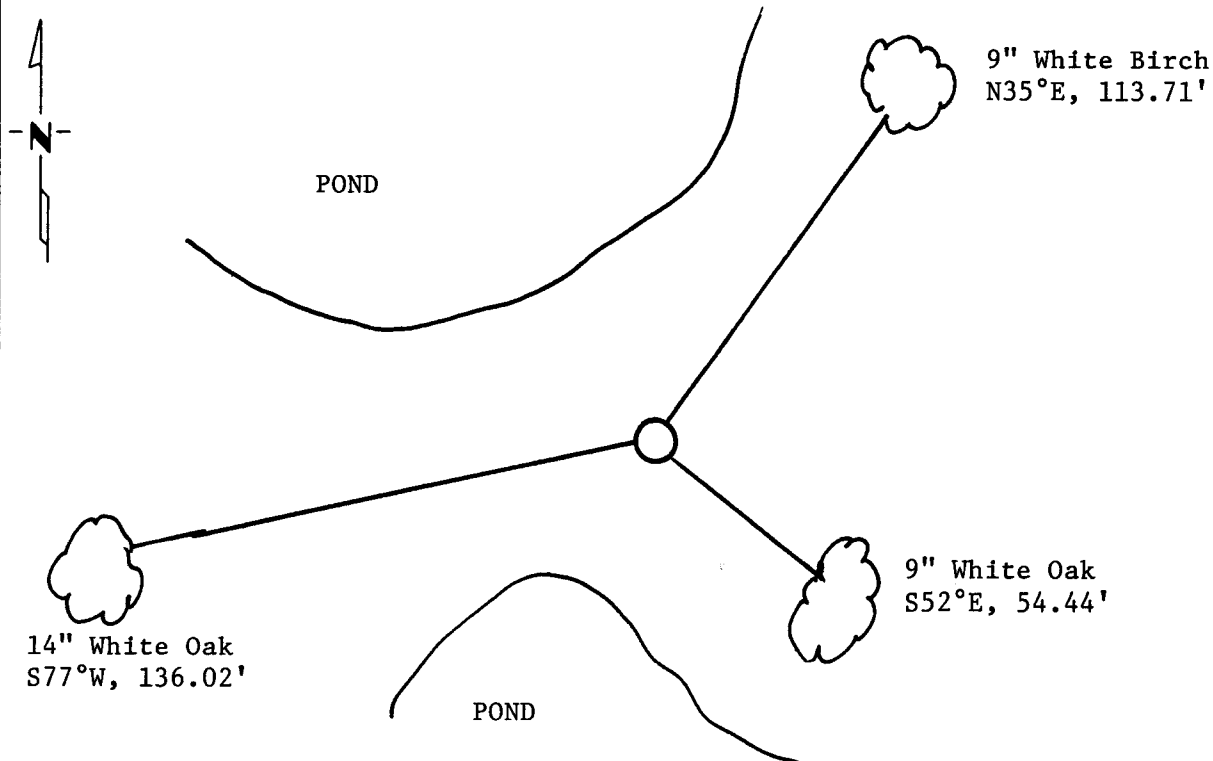

Statement of Evidence:

ORIGINAL SURVEY

1863 - This corner was established by the U.S. General Land Office surveyors at 80.00 chains, whereby a wood post was set with 4 bearing trees:

- 10" White Pine, N82°E, 15 Links
- 9" Scrub Pine, S33°E, 15 Links
- 15" White Pine, S80°W, 94 Links
- 15" White Pine, N75°W, 73 Links

SUBSEQUENT SURVEYS

1937 - CCC crew from Washburn Lake found capped 2 1/2" iron pipe - Book 1, page 52

1938 - Book 20, page 40 - called iron pipe 100' West of State Highway #6

?Date- George A. Ralph, survey of State Highway #6, made note of corner, book 8, page 90 - 91.

1998 - Landecker found corner, set steel fence post along side of iron pipe and made 3 new bearing trees:

- 9" White Birch, N35°E, 115.71 feet
- 9" White Oak, S52°E, 54.44 feet
- 14" White Oak, S77°W, 136.02 feet

I accept this iron pipe as the perpetuated position of the Section Corner.
