CERTIFICATE OF LOCATION OF GOVERNMENT CORNER

36 140 North 27 West
Corner to Sec. 31 T. 140 North R. 26 West

I hereby certify that on 2nd day of December, 1940
I found the one-quarter Corner to Sec. 31 T140N R26W

which was evidenced by All evidence lost but I re-established the corner. (See below)
and I further certify that to perpetuate the location of such corner I did at the exact location thereof place a permanent marker consisting of an 1-1/2" iron pipe, 4-1/2' long, capped and stamped.

I further certify that I established two bearing trees for
reference or witness monuments consisting of an 8" Tamarack and a 12" Jack Pine.
which reference or witness monuments are located in the manner following:

Tamarack 8" N 39 E 20.3 Feet

Jack Pine 12" N 19 1/2 W 130.8 Feet.

To locate this corner I started south from the accepted iron pipe corner to Sec. 25 & 36 T 140 N R 27 W and Sec. 30 & 31 T 140 N R 26 W - Set by County Surveyor Green in 1924 - on a line bearing S 6 W and ran four miles to the accepted iron pipe corner for Sec. 13 & 24 T 139 N R 27 W and Sec. 18 & 19 T 139 N R 26 W - Set by Deputy County Surveyor H. S. Todd - setting a temporary corner on the ice on Lake George for the corner to Townships 139 & 140 North Ranges 26 & 27 West. Then I started East from the accepted corner to Sec. 35 & 36 T 140 N R 27 W and Sec. 1 & 2 T 139 N R 27 W - Set by Deputy County Surveyor H. S. Todd and 1913 from original evidence and relocated by County Surveyor Green - on a line bearing N 84 E and ran to the iron pipe 1/4 corner Sec. 31 T 140 N R 26 W and Sec. 6 T 139 N R 26 W - set by County Surveyor Green - setting a temporary corner to the four townships on the ice. By double proportion I located the corner to Townships 139 & 140 North Range 27 West and Townships 139 & 140 North Ranges 26 West.

Then by single proportion I located the 1/4 corner to Sec 36 T 140 N R 27 W and Sec. 31 T 140 N R 26 W.

On the above work I used a Gurley Transit, a standard 100 foot steel tape, and a plumb bob in breaking chain.
