

CERTIFICATE OF LOCATION OF GOVERNMENT CORNER

Corner to Sec. 1 T. 139 North R. 27 West

I hereby certify that on 16th day of December, 19 40

I found the one-quarter Corner to Sec. 36 T 140 N R 27 W
1 T 139 N R 26 W

which was evidenced by All evidence lost but I re-established the corner. (See below)
and I further certify that to perpetuate the location of such corner I did at the exact location thereof place a permanent marker consisting of an 1-1/2" iron pipe, 4-1/2' long, capped and stamped.

I further certify that I established two bearing trees for
reference or witness monuments consisting of an 8" Birch and a 6" Birch
which reference or witness monuments are located in the manner following:

- Birch 8" S 10 1/2 W 42.2 Feet
Birch 6" N 19 0 35' W 25.5 Feet

To locate this corner I started south from the accepted iron pipe corner to Sec. 25 & 36 T140N R27W and Sec. 30 & 31 T140N R26W - Set by County Surveyor Green in 1924 on a line bearing S 6 E and ran four miles to the accepted iron pipe corner to Sec. 13 & 24 T139N R27W and Sec. 18 & 19 T139N R26W - set by Deputy County Surveyor H.S. Todd setting a temporary corner on the ice on Lake George for the corner to Townships 139 & 140 North Ranges 26 & 27 West. Then I started East from the accepted corner to Sec. 35 & 36 T140N R27W and Sec 1 & 2 T139N R26W - set by Deputy County Surveyor H.S. Todd in 1913 from original evidence and relocated by County Surveyor Green - on a line bearing N 84 E and ran to the iron pipe 1/4 corner Sec. 31 T140N R26W and Sec. 6 T139N R26W - set by County Surveyor Green - setting a temporary corner to the four townships on the ice. By double proportion I located the corner to Townships 139 & 140 North Range 27 West and Townships 139 & 140 North Range 26 West.

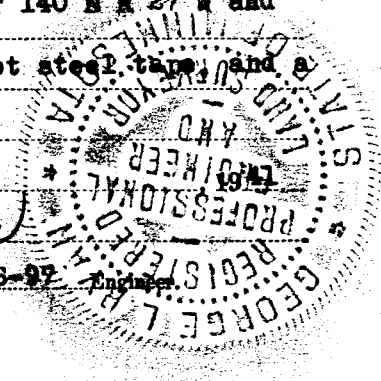
Then by single proportion I located the 1/4 corner to Sec. 36 T 140 N R 27 W and Sec. 1 T 139 N R 27 W.

On the above work I used a Gurley Transit, a standard 100 foot steel tape, and a plumb bob in breaking chain.
