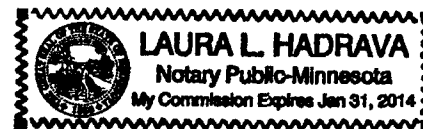

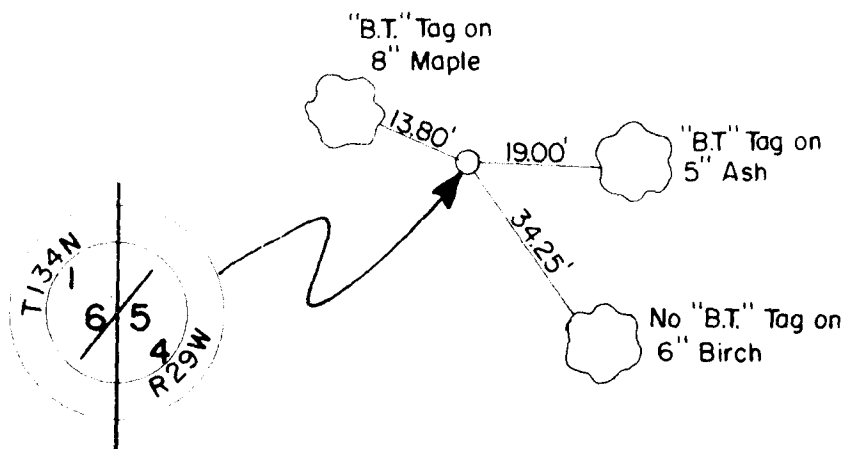

I HEREBY CERTIFY THAT ON THE 28TH DAY OF NOVEMBER, 1966, THAT I, DEAN M. ANDERSON, A REGISTERED LAND SURVEYOR, FOUND THE QUARTER CORNER BETWEEN SECTIONS 6 & 5, TOWNSHIP 134 NORTH, RANGE 29 WEST, WHICH WAS EVIDENCED BY A WOOD STAKE IN AN EARTH MOUND AND I FURTHER CERTIFY THAT ON THE 4TH DAY OF APRIL, 1967, IN ORDER TO PERPETUATE THE LOCATION OF SUCH CORNER, I DID, AT THE EXACT LOCATION THEREOF, PLACE A PERMANENT MARKER CONSISTING OF A CASS COUNTY CAST IRON MONUMENT, FLUSH WITH THE SURFACE.
