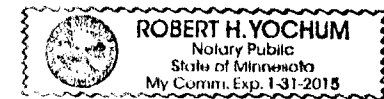

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 23rd day of August, 1963, I found the South West 1/16 corner of section 26 which was evidenced by a 2" diameter iron pipe from a survey by Cass County Surveyor James H. Flynn in 1921.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 60" long cylindrical concrete monument, capped with a 3" diameter bronze tablet stamped:-

SW 1/16 S 26
1963
R.L.S. No. 6807

from which reference or witness monuments are located in the manner following:

Elm 6" N40°E 22.8 feet Scribed SW 1/16 BT
