

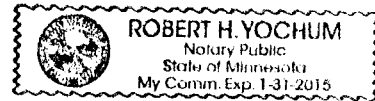

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 12th day of September, 1963, I found the Quarter corner of Sections 28-33 which was evidenced by 1½ inch diameter iron pipe - Notes of C. J. White, Cass County Engineer.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 6" diameter 60" long Cylindrical Concrete Monument 26" in ground and
