



WILLIAM H. OKERMAN, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 3rd day of September, 1963, I found the Meander corner of Sections 10 - 11 which was evidenced by the remains of the original Government Survey of 1872, which consisted of a squared scribed post.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 60" long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:

T142N R26W
 S10 S11
 MC
 1963
 R.L.S. no. 6807

from which reference or witness monuments are located in the manner following:

Red Pine 17" N54°E 237.3 feet scribed MC S11 BT

Cedar Post 4x4x60" with red top set 24" in ground N56°W 5.1 feet

Cedar Post 4"x4"x60" with red top set 24" in ground with signs 54-4 and 54-2 attached due north 3.7 feet.
