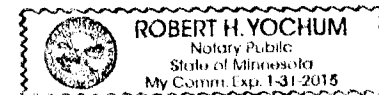

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 23rd day of September, 1963, I found the section corner of sections 8-9-16-17 which was evidenced by 2 inch diameter iron pipe with cap stamped: set by Cass County Surveyor J. H. Flynn in 1916.
