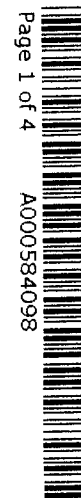

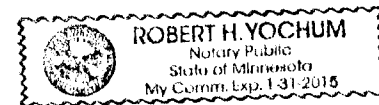

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 25th day of August, 1967, I found the Angle Point #1 of Allotment 1565 corner of Sections 20 - 29 which was evidenced by remains of the G.L.O. resurvey of 1917, consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:
