AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

VILLIAM H. OKURMAN , being first duly sworn, deposes and says: That I reside at Bemidji Minnesota and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807 I further depose and say that on the 28th day of October , 19 63, I found the Center 1/4 corner of Section 15 which was evidenced by notes from U.S.F.S. Headquarters. 24" White Pine Stp East 39 feet 30" N12°E White Pine Stp hl feet

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 60" long, galvanized steel monument filled with concrete T11.2N R26W and capped with a 3" diameter bronze tablet stamped:

C 1/4 S15

1963

R.L.S. no 6807

from which reference or witness monuments are located in the manner following:

W. Spruce 13" N60°W 109.1 feet scribed C 1/4 515 LT

W. Pine 20" S59°W 119.4 feet scribed C 1/4 S15 BT
