



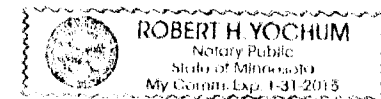

WILLIAM H. OKERMAN, being first duly sworn, deposes and says:
 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
 I further depose and say that on the 28th day of October, 1963, I found the Center 1/4 corner of Section 15 which was evidenced by notes from U.S.F.S. Headquarters.

White Pine Stp 24" East 39 feet

White Pine Stp 30" N12°E 41 feet

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 60" long, galvanized steel monument filled with concrete

and capped with a 3" diameter bronze tablet stamped:
