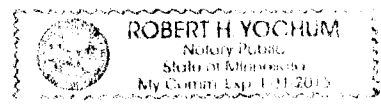

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.  
I further depose and say that on the 15th day of December, 1965, I found the Angle point #5 corner of Section 22 which was evidenced by remains of the G.L.O. survey of 1918, consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:
