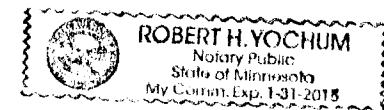

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 20th day of September, 1963, I found the Section corner of sections 15-14-22-23 which was evidenced by remains of original government survey of 1872.

White pine 36" N80°E 15.18' (found decayed pine stump at record bearing and distance)

Also found a very old squared post with scribe visible marking corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 60" long cylindrical concrete monument capped with a 3" diameter bronze tablet and stamped:-
