





WILLIAM H. OKERMAN, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 9th day of October, 1963, I found the Witness corner of Sections 13-24-18-19 which was evidenced by remains of original Government Survey of 1872.

Elm 6" N22°E 6.60' (now an elm stump and broken off windfall with blaze partly overgrown.)

W. Pine 8" N46°W 13.86' (now a burned out pine stump.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter galvanized steel monument 60" long 36" in ground with a

from which reference or witness monuments are located in the manner following:

Rock 3x3½x1' S70°W 23.7 feet with x chiseled on top.

Steel sign post 72" long 2½" in ground due south 1.1 feet with signs 54-4 and 54-2 attached.
