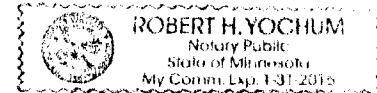

William H. Okerman, being first duly sworn, deposes and says:
 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
 I further depose and say that on the 24th day of September, 1963, I found the Center North 1/16 corner of Section 8 which was evidenced by the remains of a survey by Cass County, J. H. Flynn in 1920 recorded in record book C, pages 386-387.

Maple 9" S56°W 10 Feet - in field.

R. Oak 11" S57°E 17 feet (now oak stump at record bearing and distance)
 (Badly burned)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter 60 inch long cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped:-
