William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 10th day of October, 1963, I found the Section corner of Sections 1-6-31-36 which was evidenced by remains of a survey by Dorman J. Smith, Engineer 1" x 30" iron pipe and wood stake (found point of wood stake and pipe)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 60" long galvanized steel Monument 36" in ground and capped with a 3" diameter bronze tablet stamped
