

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 30th day of September, 1966, I found the Center Quarter corner of section 7 which was evidenced by remains of the G.L.O. resurvey of 1919. Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped C $\frac{1}{4}$ S7 1919
J Pine 20 inch S19°W 67.98 feet (now a 26 inch S19°W 67.98 feet scribe overgrown)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as this G.L.O. brass cap is in good condition.
