That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 20th day of June, 1968, I found the Quarter corner of Section's 26 - 27 which was evidenced by Cass County survey of 1920, survey record #443, Book C, page 378. Set 2 inch X 48 inch iron monument - found as described.

W. Oak 8 inch S35¼°W 36.4 feet - now 12 inch at record bearing and distance.

W. Ash 6 inch S45°E 26.3 feet - found stump hole at record bearing and distance.
