

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 23rd day of January, 1964, I found the Center South 1/16 corner of Section 16 which was evidenced by the monument and two remaining bearing trees from the GLO survey of 1918.

1 inch diameter iron post with a brass cap stamped: S 1 | S 16  
 16 | C  
 1918

Poplar 8 inch N40 3/4°E 38 links or 25.08 feet (Now a stump at record bearing & distance).

Poplar 10 inch N42°W 96 links or 63.36 feet (Now a stump at record bearing & distance).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GLO brass cap is in good condition.
