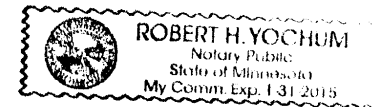

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 15th day of February, 1963, I found the North 1/16 corner of Sections 17 - 18 which was evidenced by the remains of the G.L.O. resurvey of 1918.

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped:-
 Cedar 13 inch N46°E 8 links (5.28') (Now a 13 inch cedar stump scribed "N 1/16 S17 BT" at record bearing and distance.) N 1/16
 Cedar 11 inch S59°30'W 16 links (10.56') (Now a cedar stump partly decayed at record bearing and distance.) S 18 | S 17
 1918

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Ash 4 inch N81°E 7.6 feet marked X BT

Ash 4 inch N61°W 6.45 feet marked X BT

Cedar 9 inch S11°E 24.3 feet marked N 1/16 S17 BT

Steel sign post 72 inches long, set 24 inches in ground, with standard signs 54-2 and 54-1 attached due South 4.75 feet.

All reference bearings are true bearings.
